Subject: Approval of On-Call Contractors Agreements for Measure B

<u>Background</u>: At the April 17, 2007 Board Meeting, the Uniform Public Construction Cost Accounting Act and Accounting Procedures was adopted to assemble a pool of qualified contractors to provide construction services in various construction trade disciplines. These trade disciplines included, but not necessarily limited to general engineering and building contractor, HVAC, low voltage, concrete, electrical, plumbing, and roofing.

The terms of these On-Call Contractors Agreements are for four (4) consecutive, one (1) year Renewal Terms following the Initial Term in which the District's Board of Trustees shall have the sole and exclusive discretion to exercise the right to renew the on-call agreement for the Renewal Terms. The total value of these agreements will not exceed \$125,000 annually which is within the guidelines of Board policies of the Informal Bidding Act.
