consultant's duties and, based upon that description, a statement of the extent of disclosure requirements. The Chancellor's determination is a public record and shall be retained for public inspection in the same manner and location as this conflict of interest code.

DISCLOSURE CATEGORIES

Category 1

- A designated employee in this category shall disclose:
- a) Interests in real property.
- b) Investments and business positions in or income from sources which engage in building construction or design.
- c) Investments and business positions in or income from sources which engage in the acquisition or disposal of real property.

Category 2

A designated employee in this category shall disclose:

- a) Investments and business positions in or income from sources which manufacture or sell food items, supplies, books, machinery or employment of the type utilized by the administrative unit for which the designated employee is manager, director, or responsible.
- b) Investments and business income in or income from sources which are contractors or sub-contractors engaged in the performance of work or services of the type utilized by the administrative unit for which the designated employee is manager, director, or responsible
