AGREEMENT

CHABOT-LAS POSITAS COMMUNITY COLLEGE DISTRICT

AND

AB 86 MID ALAMEDA COUNTY CONSORTIA MEMBERS

THIS AGREEMENT is made and entered into as of the 20th day of May, 2014 by and between CHABOT-LAS POSITAS COMMUNITY COLLEGE DISTRICT (hereinafter referred to as "District") and the following AB 86 Mid Alameda County Consortia Members (hereinafter referred to as "Members"): 1) Castro Valley Adult School; 2) Chabot College; 3) Dublin Unified School District; 4) Hayward Adult School; 5) Las Positas College; 6) Livermore Unified School District; 7) Pleasanton Unified School District; 8) San Leandro Adult School; and, 9) San Lorenzo Adult School.

WITNESSETH:

- A. District and Members have heretofore entered into an agreement to coordinate the following services:
 - District will serve as the fiscal agent for the AB 86 Adult Education planning grant.
 - District will disseminate grant funds to consortia as voted upon by consortia members (budget included within Appendix A).

This Agreement is in force from May 20, 2014 through June 30, 2015 and may be terminated by any party in thirty (30) days by giving written notice of the intention to terminate the agreement.
