PUBLIC COMMENTS

Ms. Martha Konrad, Mr. Todd Steffan, Dr. Charlotte Lofft, Ms. LaVaughn Hart, Ms. Debbie Earney, and Dr. Tom Orf spoke to the recent voting process and selection outcome

for the Trustee Area 7 seat on the Board. Individuals spoke in support of Mr. Donald Milanese, citing his experience and passion for the College and District. Individuals expressed strong disappointment that Mr. Milanese was not selected to serve on the Board. Individuals expressed that the comments were not personally directed at Mr. William Macedo. Dr. Lofft and Dr. Orf also questioned the time for the Administration of Oath of Office on the agenda.

Dr. Tom Orf expressed that "bypassing the appointment of Milanese evidences disrespect for the many, many years of service he has given to this district." Dr. Orf also expressed that the failure to appoint Mr. Milanese "evidences that the Board is out of touch with the campus and has broken a feeling of trust and collegiality."

Ms. Jennifer Tate, personally known by Mr. Macedo, administered the Oath of Office to Mr. William Macedo. Mr. Macedo then took his seat at the Board dais.

ADJOURN TO CLOSED SESSION

Motion No. 1

A motion was made and seconded to adjourn to a Closed Session at 4:40 p.m., which ended at 6:10 p.m.

Motion carried unanimously, 5-0, with Trustees Cedillo and Gin absent.

OPEN SESSION

The Board readjourned in Open Session at 6:31 p.m. Recording Secretary Beverly Bailey called the roll. Trustees Cedillo and Gin were absent and excused at the time of roll.

Mr. Lorenzo Legaspi led the pledge to the flag.

PUBLIC COMMENTS

Dr. Charlotte Lofft spoke regarding the appointment process for the selection of the Trustee Area 7 seat. She reported that the questions posed to the candidates for the vacant position on the board on January 27, 2014 were identical to those asked on August 2, 2005 when the board interviewed for an open seat, now occupied by Dr. Hal Gin. She also reported that she believed those questions were displayed on the District's web site as part of the minutes of

that Board Meeting. She noted that a savvy candidate could have been completely prepared for the interview. She also expressed concern that the trustee was sworn in prior to the 6:30 pm open meeting, noting that this time was not immediately posted to the public. She questioned if there were violations of the Brown Act or the League standards, which required open discussion and open vote of the candidates.

Ms. Tina Inzerilla, Las Positas College, Library Director, reported that on Friday, April 17 Las Positas College would host its 40^{th} Anniversary Celebration – "Four Decades of Scholarship." She reported that at this event, the Library will have a ceremonial ribbon cutting and tours after its remodeling. She reported that the celebration will follow the Chancellor's Award Luncheon.

Mr. William Eddy, S.E.I.U., Local 1021, reported that on February 12, a "kick-off" was held for the Wellness Initiative at the Kaiser Garfield Center, San Leandro. He reported that the event was well attended by Chabot College, Las Positas College, and District staff. He reported that all three sites will host wellness events geared for staff.

Mr. Todd Steffan and Ms. Mary Nelson, Las Positas College Veterans First Program, reported that on Thursday, March 12, 2015 the 3rd Annual Event Honoring Women Veterans will be held from 10:00 am to 12:00 Noon in the Mertes Center. Special Guest Speaker will be Star Lara, decorated U.S. Army Veteran (1995-2007).

PRESIDENTS OF CHABOT AND LAS POSITAS COLLEGES FACULTY SENATES

Dr. Tom Orf, President, Las Positas College Faculty Senate, had no report at this meeting.

Ms. Laurie Dockter, President, Chabot College Faculty Senate, reported that Faculty representatives will attend the planning Charrette on Friday, February 20. In addition, the Senate is working on shared governance and equity issues.

PRESIDENTS OF CHABOT AND LAS POSITAS COLLEGES AND DISTRICT CLASSIFIED SENATES

Mr. Todd Steffan, Co-President, Las Positas College Classified Senate, reported that the Classified Senate agreed to donate towards scholarships for students. He also reported that representatives will attend the upcoming Granlibakken Classified Training. Further, he reported that plans are underway for the upcoming Flex Day.

Mr. Gordon Watt, President, Chabot College Classified Senate, expressed appreciation to the District Office and Chabot College for their donations to the Chabot College Classified Senate "Warm Coat" campaign. He reported that 85 warm coats were collected and donated.

PRESIDENTS OF CHABOT AND LAS POSITAS COLLEGES ASSOCIATED STUDENTS

Mr. Rafi Ansari, President, Associated Students of Las Positas College (ASLPC), reported that ASLPC will participate in the "March in March" in Sacramento on March 2. Issues include making Community Colleges free and reducing textbook prices. He also reported that the Las Positas College annual "Club Day" is scheduled for February 25.

Student Senate of Chabot College had no representation at this meeting.

GOOD OF THE ORDER

Mr. William Eddy, President, S.E.I.U., Local 1021, expressed appreciation to the Board for approving the Classified Contract; and expressed appreciation to the members of S.E.I.U., Local 1021 for ratifying the contract.

Dr. Charlotte Lofft, President, Chabot-Las Positas Faculty Association, reported that the Faculty Association Executive Board voted unanimously to adopt a resolution to support Mr. Don Milanese for the Board of Trustees. The resolution also states for the record that "the recent Board of Trustee action of bypassing Mr. Milanese for appointment to the Board evidences disrespect for the many, many years of faithful service he has given to this District."

The Board accepted without discussion the Informational Personnel Report.

The Board accepted without discussion the Quarterly Financial Status Report – CCFS-311Q for the Period Ending December 31, 2014.

PRESIDENTS OF CHABOT AND LAS POSITAS COLLEGES

Dr. Barry Russell, President of Las Positas College, provided a written report "<u>Las Positas</u> <u>Connection</u>." He highlighted the Las Positas College 40th Anniversary Celebration on Friday, April 17; as well as the Las Positas College Foundation's Best of the Best on Saturday, April 25. Further, he shared the Las Positas College Foundation's recent newsletter.

Dr. Susan Sperling, President of Chabot College, submitted a written report to the Board. She recognized Dr. Stacy Thompson for the events scheduled for this month - Black History Month. She highlighted the Chabot "kick-off" of Black History Month was held on February 3 with many traditional rituals (music and dance), and keynote speaker Ms. Elaine Brown, former leader of the Black Panther Party and author. Dr. Sperling also reported that last semester a series of three Shared Governance Planning Retreats were held to strengthen their Shared Governance processes. These retreats produced a number of significant recommendations in updating their processes, including combining committees with similar planning functions, moving from consensus decision making to voting, and forming a better nexus between strategic planning and budget allocations. These recommendations, along with the next steps, were presented to the Chabot College community at Flex Day on February 12; and each group (Classified, Faculty, and Student Senates) will gather feedback and make recommendations to College Council.

CHANCELLOR REPORT

Chancellor Jackson reported that she and Trustee Isobel Dvorsky just returned from Washington, D.C.; attending the Association of Community College Trustees (ACCT) National Legislative Summit. She provided for the Board copies of the Association of American Community Colleges (AACC) as well as the ACCT Federal Legislative Priorities. She also provided a packet of materials from the Community College League of California (CCLC). She reported that while there, they literally "walked the halls of the congress." They met with Congressman Eric Swalwell, who is interested in showcasing some of our programs - Veterans Program at Las Positas College and the Law Pathway at Chabot College. In addition, speakers, moderators, and presenters at the summit included Second Lady Jill Biden; Senator Al Franken; representatives for Under Secretary of Education Ted Mitchell; Clarence Anthony, Executive Director of National League of Cities; Ann Compton, White House correspondent; William Kristol, Republican Political Analyst; and Stephanie Cutter, Co-host of Crossfire. She also reported that Secretary of Labor Mark Perez attended the California Caucus. She further reported that District materials were distributed and information shared; and stressed the need for continued advocacy in support of federal funding for our programs and services.

Board of Trustees Minutes

Chancellor Jackson also reported that on Friday, February 20, external and internal constituents will meet for an all-day Charrette. She also expressed appreciation to Bill Eddy for the reminder of the Wellness Initiative. She also expressed appreciation to Tina Inzerilla for changing the time of the 40th Anniversary Celebration to avoid conflicting with the Chancellor's Award Luncheon.

TRUSTEE REPORTS AND/OR OFFICIAL COMMUNICATIONS

Student Trustee Ms. Dolorito reported that the Student Senate is continuing its efforts with the Water Bottle stations; reporting that the Senate approved \$17,500 for the project. She reported that the Chabot College Foundation has expressed interest in helping fund the program, as well as the Facilities Committee. She expressed appreciation to the community for the beautiful new library furniture. She reported that the Student Senate has started a photo campaign of "what free community college would look like." She also reported that on Tuesday, March 3 the Student Senate will hold a Literacy Drive, which is open to high schools and elementary schools. Further, she recognized the recent news article highlighting Tom Hanks.

Student Trustee Mr. Bolin reported that ASLPC will participate in the "March in March" in Sacramento on March 2. He also reported that elections are coming up for Student Government. He also reported that the ASLPC representatives will be attending an upcoming conference in Sacramento or Washington, D.C.

Trustee Mr. Vecchiarelli reported that he hopes that there will be advertising to the public for the 2016 and 2017 Men's and Women's Basketball State Championships to be held at Las Positas College.

Trustee Dr. Mitzman reported that on February 27, the Hayward Education Summit will be held. He reported that Hayward is an "Education City", with a 2-year college (Chabot College), a 4-year college (California State University East Bay), and a chiropractic college. He reported that at any given day, Monday through Friday, there are 80,000 students attending classes in the City of Hayward. He recognized Dr. Susan Sperling who is very involved with the community cooperation in education.

Trustee Mrs. Dvorsky reported that the AACC/ACCT sponsored Conference held in Washington, D.C. was very exciting; and offered to share the program materials. She reiterated Dr. Jackson's reporting of "walking the halls of congress." She reported that they spoke with a number of Congressmen. She reported that she spoke to Congressman Mark Takano, Southern California, who is very interested in Veterans Programs. She reported that the next ACCT Conference will be held in San Diego in September.

Trustee Mr. Macedo expressed that he is honored to serve on this Board and expressed appreciation for the opportunity to serve.

Trustee Mr. Gelles expressed appreciation to everyone for attending and for participating.
