## **PUBLIC COMMENTS**

Ms. Rozen Bondoc, Advisor and Mr. Alex Prasadi, Chabot College Student Veterans' Organization, announced the Chabot College Third Annual Toys for Tots Toy Drive. A free lunch event in exchange for a new unwrapped toy is scheduled for the final day of collection on Thursday, December 10 from 11:00 a.m. to 2:00 p.m. in the Event Center, Building 200.

Mr. Lawrence Aguiar and Mr. Kerry Karter, Las Positas College Faculty, Kinesiology Department, reported their concerns regarding the department's operations, i.e. lack of transparency and shared governance, unprofessionalism, favoritism, retaliation, and abuse of power. Mr. Aguiar reported that the proper channels have been taken but their concerns continue, and he is requesting a confidential meeting. Mr. Aguiar reported that he will visit every Board meeting until things change within the department.

Mr. Dave Fouquet, Co-Chair, Integrated Planning and Budget Model (IPBM) Districtwide Facilities Committee, presented the committee's recommendation. The recommendation cites that major educational and seismic/safety needs will continue to exist after all the Measure B funds are depleted. As such, the committee recommends that the District seek supplemental funding through General Obligation Bonds by way of a ballot measure during the 2016 election cycle. He provided a handout to the Board, which cited eight points for their rationale.

Ms. Donna Gibson, Chabot College MESA/TRIO/STEM, provided an update on the Programs. She reported that the College is in the 4<sup>th</sup> year of the MESA grant. She provided a breakdown of the ethnicity of the students in the program; as well as the Success and Completion rates. She shared students' comments about their experiences with the program. She reported that the 12<sup>th</sup> Annual Mathematics, Engineering, Science Achievement (MESA) Student Leadership Conference was held October 2-3 in Santa Clara; and two Chabot students (Michael Choi and Victor Zendejas Lopez) were selected to attend a special invitation-only conference for math-based majors in the country's science, technology, engineering and math (STEM) innovation hub. She reported that the hand-picked MESA students, all science, engineering, or math majors, represented 38 universities and community colleges from across the state.

Dr. Maria Ochoa, Executive Director of Chabot College Development and the Foundation, reported on the recent Second Annual Gala and Fundraiser held on November 12, 2015 at Stonebrae Country Club in Hayward. She expressed appreciation to Board Members and all those that attended. The keynote speaker was Ms. Wendy Tokuda; and Congressman Eric Swalwell was honored. She also reported that the Mohr-Fry Family, previous owners of the Chabot College property, were recognized. She reported that the first quarter of last year the Foundation raised \$17,000; and the first quarter of this year raised \$97,000. She

also reported that retired Chabot College Dean Glenn Leuning has endowed a \$1,000 a year student scholarship. She reported that 37 students applied for the scholarship; and of those 37 students, one-third were 4.0 GPA and half were 3.5 GPA students; and all were transferring to 4-year institutions.

Ms. Sheila Mayorga and Mr. Alan Roberson, Student Senate, Chabot College (SSCC), expressed student concerns regarding food options and pricing at the Cafeteria. Ms. Mayorga reported that she serves on an Ad Hoc Food Committee on tackling these issues. She reported that at the last two Town Hall Meetings, the biggest concern expressed by students was the unsatisfying quality of the cafeteria food. She reported that the Senate has been working on improving the quality of the cafeteria food; and also seeking discounts at local restaurants, and different vending machine options. In addition, they are looking into the Cal Fresh Program for qualifying students and establishing a food pantry. Mr. Roberson personally shared his experience, noting that he is not alone, with the problem of focusing on your education when your nutrition needs and requirements are not being met. They asked the Board for its endorsement of bringing change to this issue at Chabot College.

Dr. Tammy Robinson, President, Western Region Council of Black American Affairs (WRCBAA), introduced herself and Dr. Carol Belle-Thomas. They presented to Dr. Jannett N. Jackson the Regina Stanback Stroud Leadership Achievement Award, noting that the award is the most prestigious award that the WRCBAA has to offer. The award is given to those who exemplify visionary guidance, dedication, undaunted leadership, and service to Community Colleges. She recognized Dr. Jackson for leading with the three pillars of success - Educational Excellence, Curriculum Relevancy, and Community Collaboration.

# PRESENTATION: GRANTS UPDATE, CHABOT-LAS POSITAS COMMUNITY COLLEGE DISTRICT

Chancellor Jackson reported that at the request of the Board, a brief summary is provided on the grants held by the Colleges and Economic Development/Contract Education. She reported that a grants presentation was last provided to the Board on October 21, 2014. She reported that the presentation provides some brief details on a number of grants as well as highlights of specific grants that are of particular note. She reported that securing grants is time-consuming and each of the presenters should be commended for their efforts to

apply for, secure and manage numerous grants. She introduced the presenters - Dr. Barry Russell, Las Positas College; Ms. Julia Dozier, Economic Development/Contract Education; and Ms. Yvonne Wu Craig, Chabot College.

#### **Board Questions/Comments:**

Trustee Dr. Cedillo expressed the great opportunities these grant funds provide. He cautioned the challenge for the District with staffing and space. He questioned what happens long-term with staff hired when the grants are no longer providing funds. In response, Chancellor Jackson reported that the District job announcements stipulate that the positions "are contingent upon grant funding." Vice Chancellor Fong reported that the Colleges are keenly aware of this issue and have been working with the District in establishing these positions with staffing without a future adverse impact on layoffs.

## PRESIDENTS OF CHABOT AND LAS POSITAS COLLEGES FACULTY SENATES

Ms. Melissa Korber, President, Las Positas College Faculty Senate, reported that the Faculty Senate has approved the Faculty Hiring Prioritization and the Committee has recommended 29 positions. In October the Committee approved the first two tiers of ranking; and in November will rank the final tier. Further, she reported that the Senate has unanimously approved the Educational Master Plan, noting that the Task Force that worked on the Plan over the Summer was led effectively by Mr. Rajinder Samra. She reported that the Faculty Senate approved a formal resolution of excellence award for Rajinder Samra, in large part for his work at the College and for his support of Faculty and the College. She also reported that the Faculty Senate nominated a Program for a Statewide Academic

Senate award – The Exemplary Program Award for the learning community between Early Childhood Development and Math, which has increased Math scores to 84%. Further, she reported that the Academic Senate is sponsoring a Scholarship Challenge, and the division that contributes the most will have a scholarship in its name.

Ms. Laurie Dockter, President, Chabot College Faculty Senate, reported she attended the recent Statewide Academic Senate Meeting, noting she attended a presentation on the history of Accreditation. She reported that there are discussions of hiring a new accreditation body. She was able to get a sense of what is occurring; that IEPI is to give us more information on how we are doing and make the process more uniform. She reported that the IEPI is a Model Program in its first year and more information will be coming. She also noted much discussion at the Statewide Academic Senate on curriculum, CIDs, Transfer Degrees, Bachelor Degrees, and non-credit opportunities. She also attended a session on budget and hiring and noted discussions regarding recalculating of Faculty Obligation Numbers (FON). She also reported that Chabot College will hire five (5) new Faculty this year and will hire more next year (from \$62 to \$82 million statewide). Further, she reported that Chabot College Faculty are asking for more clarity on how monies come to the Colleges from the budget.

# PRESIDENTS OF CHABOT AND LAS POSITAS COLLEGES AND DISTRICT CLASSIFIED SENATES

Las Positas College Classified Senate had no representation at this meeting.

Ms. Noell Adams, President, Chabot College Classified Senate, reported that the Classified Senate has approved funding four (4) members to attend the Community College League of California (CCLC) Annual Convention this week. She also provided an update on the Classified Leadership Program, which was initiated by Chancellor Jackson. She reported that two members of each of the three Classified Senates and Dr. Jackson visited Merced County Office of Education and Clovis Community College to look at their programs. She also reported that the Senate has been reviewing the Classified Prioritization Process.

Ms. Rachel Ugale, District Classified Senate, had no report.

# PRESIDENT OF STUDENT SENATE OF CHABOT AND PRESIDENT OF ASSOCIATED STUDENTS OF LAS POSITAS COLLEGES

Ms. Hye Yoon Shin, President, Student Senate of Chabot College, reported that the Student Senate will soon open an Advocacy Office in Building 2300. She also reported that the Senate is working on their By-Laws and Constitution. She also reported that a large concern of students is the costs and options of food in the Cafeteria. She reported that Student Trustee Taylor and the Legislative Director recently attended the General Assembly of the Student Senates of the California Community Colleges (SSCCC), where

they were part of historic votes in favor of Resolutions from establishing all-gender restrooms to campus support offices for undocumented students. The Resolutions will now go before California legislators, but there may be plans in the works for Senators to bring some of these issues to Chabot College. Further, she reported that the Senate Finance Committee will be making funding recommendations to SSCC for approval at the November 30 meeting, noting that requests exceed the amount available in the budget.

Associated Students of Las Positas College had no representation at this meeting.

#### PRESIDENTS OF CHABOT AND LAS POSITAS COLLEGES

Dr. Barry Russell, President of Las Positas College, provided a written report to the Board "<u>Las Positas Connection</u>." He reported that the Veterans' Day Event was a huge success. He reported that Mr. Brian Thompson, Department of Education in Washington, DC, attended specifically to learn about the Las Positas College Veterans' Program. Mr. Thompson is advising Mr. Arnie Duncan, Secretary of Education, on Veteran-related issues. Dr. Russell expressed appreciation to Todd Steffan and his group, as well as to those Men and Women who have served our Country so valiantly, and are students of Las Positas College.

Dr. Susan Sperling, President of Chabot College, provided a written President's Report to the Board. She reported that on November 14 Chabot College hosted the third annual "Made in Hayward" kick-off event promoting Educational Excellence in the City of Hayward. Those attending included Congressman Eric Swalwell, City of Hayward Mayor Ms. Halliday, Superintendent of Schools Mr. Dobbs, and Trustee Dr. Mitzman. She also reported that on November 5, Chabot College hosted the East Bay High School Students for Manufacturing Day. Over 400 students participated by visiting two manufacturing sites and then came to the College for tours and lunch. She recognized the work of Dean Lima for this event. Further, she reported that the Student Veterans' Organization (SVO) hosted the first Veterans' Appreciation Week on campus from November 2 – 6. She reported that the Veterans' Center will have its Grand Opening on January 28, 2016, and recognized the work of Dr. Matt Kritscher. Further, she recognized Dr. Carla Walter on her new position as Interim Vice President, Administrative Services.

#### **CHANCELLOR REPORT**

Chancellor Jackson reported that she was honored to attend the Las Positas College Veterans' Day Event. She also reported that she attended the Groundbreaking for the City of Dublin Veterans' Family Apartment Complex with other dignitaries, including Congressman Eric Swalwell, and State Assemblymember Katherine Baker. She expressed appreciation to Mr. Doug Horner and the Facilities Department for working with Chabot College on the Chabot College Veterans' Resource Center; and she looks forward to the Grand Opening. She reported that she will attend the upcoming Community College League of California (CCLC) Conference on November 19-22. She reported that as part of the conference on Friday evening, November 20 she will co-chair the Statewide Joint

Caucus Reception [African American California Community College Trustee (AACCCT), Asian Pacific Islander Trustee and Administrators (APITA), and Veterans]. She reported that BART has received a grant to launch a training program with community colleges and local workforce investment boards to provide up to 100 students technical knowledge to pursue transit related careers. She reported that Las Positas College has submitted a proposal to serve as part of a Focus Group for the Institutional Effectiveness Partnership Initiative (IEPI). She reported that IEPI would augment the accreditation process.

#### TRUSTEE REPORTS AND/OR OFFICIAL COMMUNICATIONS

Student Trustee Ms. Taylor reported that she recently attended the General Assembly of the Student Senates of the California Community College (SSCCC), with over 600 attendees from 70 colleges represented. She recognized Dr. Kritscher for helping her attend. She was pleased to report that at the General Assembly, she received Certification for Roberts Rules of Order. She reported that students are concerned about transparency with fiscal issues and the amount of monies going to the Colleges. Further, she recognized the work of Mr. Walter Blevins for his help in opening the Student Advocacy Office, which will open soon.

Student Trustee Ms. Nancy Kang reported that Associated Students of Las Positas College (ASLPC) has donated monies to several departments, including the Interclub Council (ICC).

Trustee Dr. Cedillo congratulated the Colleges for their athletic programs, noting that Chabot College Football has qualified for the Play-offs. He requested that the Chancellor provide a follow-up report on the concerns expressed this evening regarding the Las Positas College Athletic Department. He also reported that he attended the recent Chabot College Latino Information Day, and recognized those who worked at the event. He expressed that he would like to work with Chabot College to present the information at the Union City Christian Academy.

Trustee Dr. Mitzman reported that the Salvation Army of Hayward raised approximately \$20,000 for a Thanksgiving meal, and will plan on serving a Christmas meal to those in need as well.

Trustee Mr. Macedo reported that he attended the Las Positas College Veterans' Day Event, and recognized the work of Todd Steffan. He especially acknowledged the "Veterans Stories" event held on November 4. He recognized Professor Ott for encouraging Veterans to journal their experiences.

Trustee Mr. Vecchiarelli reported, in response to Ms. Dockter's comments, that the Colleges should look at offering BS Degrees in Nursing.
