### **LPC Welding Technology Response:**

The Las Positas College Welding Technology program teach both traditional welding and advanced welding/manufacturing practices. The program will use this glove box to not only expose students to this type of equipment but to allow them to work in and around a Vacuum Atmosphere Glove Box to simulate real world situations that they will encounter on the job. Specifically it will be used in classes to simulate cleanroom environments, environments where the weldment and the welder cannot occupy the same space, in additive manufacturing applications and in other advanced manufacturing processes that require a controlled environment.. We believe faculty and staff have adequate training and experience to properly utilize the Glove Box. At this time no additional funding will be needed to effectively get the glove box into use in the classroom.

## **Institution/Nonprofit Organization Responsibilities**

- Answer technical review questions;
- Accept all terms including use of the equipment, liability, shipping/transportation costs, and export control regulations (see notice below).

## **Terms**

- A. Sandia National Laboratory agrees to provide the excess education related and Federal research equipment identified on the **SWG** Gift Title Transfer Form, as a gift to the Recipient, for the conduct of technical and scientific education and research activities.
- B. Title to the research equipment, provided as a gift, shall vest with the recipient upon Sandia's approval of this **SWG** Program Request and Agreement Form and execution of the **SWG** Gift Title Transfer Form.
- C. Recipient will be responsible for any repair and modification costs to any equipment received through this agreement.
- D. Recipient and any successors to Recipient, hereby release and agree to hold harmless Sandia National Laboratory or any person acting on their behalf, to the extent allowable by law, for any and all liability of any kind and nature whatsoever, resulting from the receipt, shipping, installation, operation, use and maintenance of the Federal equipment through this agreement.

- E. Recipient agrees to use the gift provided herein for the primary purpose for, and in the conduct of, technical and scientific education and research activities.
- F. Recipient hereby certifies that they will export or transfer title of all gifted equipment in compliance with export controls as detailed in the Code of Federal Regulations, Titles 10, 15, 22 and 31. Any export of commodities contrary to U.S. Law is prohibited. For further assistance on export control, contact the U.S. Department of Commerce, Bureau of Export Administration.

## Export Control Notice

Personal property purchased from the U.S. Government may or may not be authorized for export from the United States. If export is allowed, the purchaser is solely responsible for obtaining required clearances, approvals, and/or licenses. The purchaser also is required to pass on DOE's export control guidance if the property is resold or otherwise disposed. The required DOE export control guidance is:

The use, disposition, export, and re-export of this property is subject to all applicable U.S. laws and regulations, including the:

- Atomic Energy Act of 1954, as amended;
- Arms Export control Act (22 U.S.C. 2751 et seq.);

- Export and Import of Nuclear Equipment and Material (10 CFR part 110);

- Export Administration Regulations (15 CFR part 730, et seq.);
- Foreign Assets Control Regulations (31 CFR parts 500, et seq.);
- Espionage Act (37 U.S.C., 791 et. seq.) which, among other things, prohibit:
  - a. The making of false statements and concealment of any material information regarding the use of disposition, export or re-export of the property; and
  - b. Any use or disposition, export or re-export of the property which is not authorized in accordance with the provisions of this agreement.
