Questions and Comments:

Trustee Maduli asked, where the profit from indirect costs come from. VC Johns answered that the net proceeds to the district come primarily from the indirect costs for those grants and contracts, which may range from 4-10%. Funds within the grant and contract programs support project-specific staff expenses, so a significant portion of indirect costs become net proceeds. As Vice Chancellor Lorenzo Legaspi reported to the Board earlier, the revised Budget Allocation Model now allocates a large percentage of EDCE net proceeds to the district's OPEB irrevocable trust which benefits the colleges and district. About 20% of the annual net proceeds is retained by EDCE for program development, and another proportion goes toward rent and other 3A budget expenses, resulting in allocation model benefits to the colleges and district.

Trustee Maduli asked if profit is shared from the programs of Contract Ed. VC Johns stated the net proceeds from all the activities of Contract Ed go towards the percentages that flow under the BAM as described.

Trustee Vecchiarelli asked how the apprenticeship program is being funded. VC Johns stated that the administrative work required of apprenticeship programs is funded by the state based upon a formula related to the size of our programs and associated work. This funding from the state allows the apprenticeship administration break even. Apprenticeship enrollments and related and supplemental instruction FTES are reported by Chabot College—and in the future we expect will also be reported by Las Positas College—for state RSI funding established for that purpose. Trustee Vecchiarelli asked if there is a cap on apprenticeship programs. VC Johns stated no, and concluded by adding that CLPCCD's model for handling apprenticeship is very highly thought of within the industry.

Trustee Gelles complemented Ms. Dozier for her great work over the years.

2.2 PRESIDENTS OF CHABOT AND LAS POSITAS COLLEGES AND DISTRICT CLASSIFIED SENATES

Las Positas Classified Senate, President Ms. Cindy Robinson reported on the following items:

She stated there will be a Classified Retreat in August.

Chabot College Classified Senate, President Ms. Noell Adams reported on the following items:

She stated on June 28th, the Chabot College administrators hosted a Classified Appreciation Lunch. She thanked the administrators for putting together this special event.

She stated since the beginning of summer, she and the other members of our Institutional Effectiveness workgroup have been meeting with the chairs of the college's Planning and Resource Allocation Committee. PRAC, is charged with leading the college's integrated planning and resource allocation processes and it's in its infancy as it was established as part of the college's revised shared governance structure. The purpose of this summer work is to assess the workings of the committee during its first year of implementation and to prepare the chairs to hit the ground running when the new academic year begins in August. Among other things, they are evaluating the frequency of the committee's meetings and the establishment of focused workgroups to tackle more complex matters in a more timely fashion. She stated there also evaluating the alignment of their college and district-wide planning processes.

She stated the Classified Senate's annual Governing Council Retreat will be held next Thursday, July 26th. They have a six-member ad-hoc planning committee that has been meeting this month to coordinate all the event details, build a terrific agenda, and prepare outstanding sessions. The main purpose of the retreat is to strengthen governing council members' ability to effectively participate in shared governance and to identify some main priorities for Classified Senate this upcoming year. She stated their theme for this year's retreat is Space and their slogan, which is still a working slogan, is Reaching Beyond: Challenging the boundaries of what we know and pushing further to benefit classified professionals and the students we serve.

PRESIDENT OF STUDENT SENATE OF CHABOT AND PRESIDENT OF ASSOCIATED STUDENTS OF LAS POSITAS COLLEGE

Las Positas College Student Senate President, Ms. Lylah Schmedel reported on the following items:

She stated the Senate had their first meeting last week, where they discussed several different topics and plans and also reviewed the budget they will propose in September. She stated they are currently working on preparing for Welcome Week and raising awareness regarding their sports teams/events. She stated edits on the website are underway and they are recruiting student representatives to attend the upcoming Guided Pathways Retreat. She stated that the Food Pantry held its third event which now has reached more than 120 families. Lastly, she stated Fall Preview and Ribbon Cutting for Building 1000 have been planned and she looks forward to working closely with the Board this year.

Chabot College Student Senate President, Mr. Lorenzo Caballero reported on the following items:

He stated Mr. David Betts Human Resources Director, provided the senate a training today to secure on Hiring Committee's. He stated he is looking forward to getting to know each Board member individually and possibly scheduling and meet n greet in the near future. He stated the senate is organizing and prioritizing some projects such as a community garden and public transportation. Lastly, he stated it is their goal to ensure the students voices and perspectives are heard.

GOOD OF THE ORDER

Mr. David Fouquet, President of Chabot-Las Positas Faculty Association, stated the following: on June 27th the Supreme Court handed down the Janus v. AFSCME decision which is anti-union. He stated unions can no longer charge mandatory agency fees to be paid by non-members. He stated he has been working with Human Resources to get the members coded correctly in Banner. Lastly, he stated the new Funding Model is harmful to Districts such as ours.

Ms. Rachel Ugale, Chapter President SEIU, stated she is going through the list for reconciliation under for the Janus v. AFSCME legislation and is acting as an intermediator with Human Resources and the local union chapter. She stated that if there is any official comments being made by SEIU they will be made by the District President.
