#### 1.10 PRESENTATION: FACILITIES MASTER PLAN

Interim Chancellor Gerhard stated this evenings presentation is a continuation of the April Board meeting where the Board received an overview of the Draft Facilities Master plan. He introduced VC Letcher who gave the following presentation:

## **Questions and Comments**

President Maduli asked of the 407 million for each college, will the rest be going to the District. VC Letcher stated the balance is carried at the District-wide level with allocations

that were approved in June that include funding for I.T. Services that will be spent at the colleges.

Trustee Mitzman asked if moving the Board room to the first floor was an addition to the Master Plan. Interim Chancellor Gerhard stated this was briefly discussed in April. He stated the current Board room would be repurposed for other areas; with Contract Ed moving this would not be a loss of revenue. He stated the pros of moving the Board room to the first floor would make the Board meetings more accessible to the public. He added, in regards to the finances, by moving Contract Ed to Owens Drive and the Board room there would be additional rental space on the first floor and we would maintain cash flow positive and have rental income to operate the District building.

President Maduli asked why is OSHA and Contract Ed moving if they bring revenue into the District. Interim Chancellor Gerhard stated they have grants for being the fiscal agent on state-wide initiatives. The rental expense for their facility will be paid for by the revenue generated from those contracts and services. He added the fees at Owens Drive would not encroach on the unrestricted fund or take money away from the District. He stated another benefit to relocating Contract Ed is creating an opportunity to centralize departments under Ed C under one roof. He stated they have a lease expiring in October which provided the emphasis behind this relocation and consolidation. Trustee Mitzman asked President Maduli if a sub-committee could be formed for more discussion, as he is concerned regarding public perception. President Maduli asked what was the timeline that was proposed. VC Letcher stated the relocation of EDCE, OSHA and TriValley Career Center will take approximately six months, once that relocation is complete we will come back to the Board for final approval of the District office. Trustee Gin responded to Trustee Mitzman's comments with the Board room relocating to the first floor he is in favor of the Board room relocation so the public does not have to take the elevators. He reminded Trustee Mitzman of a recent visit they made to San Jose Evergreen Community College Districts Board room that was located on the first floor and the accessibility. Trustee Mitzman thanked Trustee Gin for his comments and asked what the size of the space is on the first floor. President Maduli asked what is the scope of work and is there ample time for addition discussion on the specifics of the Board room. He suggested more discussion around this occur with the Interim Chancellor, VC of Facilities, himself and a few Board members as we still have six months before EDCE relocates.

Trustee Mitzman asked if the Master Plan states how the property is going to be used adjacent to Las Positas College. VC Letcher stated the District owns two properties adjacent to Las Positas College, Murray Ranch 400 Acres- 200 Acres is mitigation land, Dulan Canyon Road Property. He stated there are no plans of use in the Master Plan for Dulan Canyon and the Master Planners did not have all the specifics to address that property, that is a piece we can continue conversation on moving forward. Trustee Mitzman suggested renting Dulan Canyon Road property for parking for the business adjacent to it or build student housing for Las Positas College. VC Letcher stated we can append the Master Plan as we begin study of that site. Trustee Mitzman thanked VC

Letcher for his hard work. President Maduli stated that is not included in the current Master Plan that the Board approved, there will need to be an addendum.

Trustee Sbranti stated he supports an addendum as the District has assets beyond the three identified in the report.

Trustee Sbranti asked what will be the leasable sq. ft. of what is left that we will be able to lease in terms of income, and what is the amount of income that is needed to generate the same amount of revenue as we currently have or break even off of current obligations. VC Letcher stated the building is roughly 66,000 sq. ft. which we occupy 58% of this building that includes the third, first and parts of the second floor for Ed C and OSHA. He stated when EDCE and OSHA vacate we would free up 7,000 sq. feet in this building. He added, the Board room and functions will take 3,000 sq. ft. If the Board room is not relocated down stairs we would have 7,000 sq. ft. of leasable space. Current market rate for small tenant suites is \$2.45 per sq. ft. Larger suits we can get a higher rental rate, first floor is more desirable and rents for more. He added, we are currently revenue positive in the building by occupying 58% and that number is expected to rise. Trustee Sbranti stated from a transparency stand point he supports the idea of moving the Board room to the first floor and can be repurposed. Trustee Sbranti asked since we are right on the Bart line of transportation has there been any thought of having educational offerings or programs here for our students. Interim Chancellor Gerhard stated it was not brought up in context to the Facilities Master Plan, VC Letcher stated it was not addressed in the Facilities Master Plan, District Strategic Plan or the Ed Master Plan which was done in advance of the Facilities Master Plan. He stated once this Facilities Master Plan is approved we will start a new cycle which the Ed Master Planning will begin shortly and that concept will be included. Interim Chancellor Gerhard stated in providing timing of that recently we have been having discussions on the heels of the work you see before you, leadership transitioning to our new VC of Facilities and the Presidents of the colleges this fall to renew our Educational Master Plan, at which time those discussions will be "flushed out" and be a part of those efforts. Trustee Sbranti stated with the Board and staff consideration as that process moves forward, regarding the Education Master Plan or updates and addendums is there a possibility to use some of the space that is on the Bart line for services to our students given its accessibility. He stated in relation to the Master Plan, moving forward we should coordinate working with the City of Dublin's Economic Development Department as they know of specific potential users that can help coordinate leasing space.

Trustee Granger asked if it is the will of the Board to reconsider moving the Board room; is there action the Board needs to take and is there impact to the VC of Facilities work. VC Letcher stated with every project that is listed in the Master Plan there is actions the Board needs to take to move each of these projects forward. He stated since the Board has expressed high interest with moving the Board room we will bring that back for further discussion. Trustee Granger stated it is a point of order question if the Board moves forward with approving the Master Plan. VC Letcher stated the Master Plan is a long range plan and there aren't any set timelines of those items and the Master Plan will not be affected. President Maduli stated everything comes back to the Board for final approval. He

stated in April the Board approved to move the Board room to the first floor in which he is in favor of. Trustee Sbranti stated the Master Plan is just the "Master Plan" the Board has approved a plan however, if a project comes before us we have the right to not approve it. Trustee Randolph reminded everyone, Facilities Master Plans are flexible living documents.

Trustee Randolph asked if we need to update our California Environment Quality Act, CEQA or are we covered by previous plans adopted in 2016, 2018 for the 2012 FMP. VC Letcher stated Las Positas College is covered under their previous CEQA document. He stated as we move forward a consultant will be brought in to validate those items. He added, Las Positas College is covered for all buildings, with expansion to the east of the campus and only if we were to expand to other areas that are not previously identified under its previous CEQA agreement. Lastly he stated, part of that CEQA agreement was the acquisition in dedication of 205 acres of mitigation land, known as Murray Ranch as part of that prior CEQA process but he will go back and validate the CEQA process as we move forward. Trustee Randolph stated she supports moving the Board room to the first floor.

Trustee Gin asked what the plan is during construction at Chabot College in regards to accommodating students and faculty as space is limited. VC Letcher stated from a student, safety perspective his biggest fear is the Library Learning Connection in the middle of campus. He stated with the Biology Building Phase I, they have negotiated space at Anthony Ochoa Middle School, so parking is not impacted. He added they continue to work with the community around Chabot College to provide support for offsite lay down and staging areas for materials.

Interim Chancellor Gerhard thanked VC Letcher, College Presidents and everyone at the colleges that put in 18 months of hard work.

#### 1.11 PRESENTATION: AB 705

Interim Chancellor Gerhard stated tonight's presentation is on Assembly Bill 705 that was signed by the Governor in 2017. The bill requires that a community college district or college maximize the probability that a student will enter and complete transfer level coursework in English and Math within a one-year timeframe and use. He stated our implementation deadline is Fall 2019.

Dr. Jamal Cooks, Dr. Arun Goyal, Ms. Debbie Trigg, Mr. Tony Gonzales, with Chabot College gave the following presentation:

#### IF STUDENTS HAVE AN IEP OR 504 PLAN IN HIGH SCHOOL

Students can make an appointment with the Disabled Student Resource Center DSRC counselor to review their IEP/504 plan to see if they are eligible for accommodations.

DSRC services are confidential, completely voluntary and may provide supports for students to be successful in college courses.

Students also might consider taking LNSK 116 before deciding on an English and/or Math course.

# STUDENTS HAVE THE RIGHT TO ACCESS COLLEGE LEVEL ENGLISH COURSE

English 1/1A is a college level English course. This course is transferable to a four-year university.

English 101A and 102 are not college level English courses. They are not transferable to a four-year university.

Students have the right to choose which course best suits their needs. A counselor can help support students explore their options.

#### **Questions and Comments**

President Maduli stated development courses have decreased from 42-18, what impact does that have on the FTES. Dr. Cook stated that is positive, with the English 1 course will be four unites and we are increasing the number of sections and units that are going along with that and the developmental course. The number of sections that are available fits with the demands.

Trustee Randolph asked that follow up information be shared with the Board. Dr. Cook acknowledged Trustee Randolph's request.

Trustee Gin asked if a student gets into English 101 and is unable to pass, is there a limit to how long they can continue taking the course. Dr. Cook stated the students can take the course up to three times. Ms. Trigg stated counselors have designed a First Semester Planning Session to assist students if they are struggling. Trustee Randolph asked how realistic this program is to enter and complete transfer course work for English and Math. Ms. Trigg stated they are doing their due diligence to ensure their students are taken care of. Trustee Randolph thanked the presenters.

Trustee Mitzman asked if a student can transfer without passing English 1A. Ms. Trigg stated English 1A is required to transfer.

Trustee Sbranti asked if the college website is transparent. Ms. Trigg stated yes. Interim Chancellor Gerhard welcomed Ms. Nan Ho and Dr. Stuart McElderry with Las Positas College who gave the following presentation:

## **Questions and Comments**

Trustee Sbranti asked to what extent are you articulating with Dublin, Pleasanton and Livermore School Districts on the curriculum to ensure the courses line up and students enter these transfer level courses. Ms. Ho stated they have partnerships with teachers at the area high schools and have alignment meetings to discuss Multiple Measures to ensure students know what courses to take. Trustee Sbranti stated what we are doing is great, it is important to have a curricular alignment with our local high schools.

Trustee Randolph asked if a high school student can take English 1A and Math. Ms. Ho stated an entire section of intermediate algebra is dedicated to middle college students, depending on their educational background they can take these courses.

Trustee Granger thanked both colleges for their work to adjust to this new mandate and identify courses that students can be successful.

Student Trustee Moloi asked if the free non-credit classes are available to International Students, and do those count towards the International Students hours. VP Garcia stated no.

Trustee Heredia complemented Chabot College for encouraging classes to be taught by full time faculty and providing additional support.

Trustee Randolph thanked both colleges for their efforts.

President Maduli applauded the faculty and staff for implementing Guided Pathways, AB 705 and the new Funding Formula in the past eighteen months.

# 1.12 PRESENTATION: CLASSIFIED LEADERSHIP INSTITUTE FOR PROFESSIONALS, CLIP

Interim Chancellor Gerhard stated the Classified Leadership Institute for Professionals, CLIP is a leadership development program unique to Chabot-Las Positas Community College District. CLIP fosters a supportive culture and cultivates effective leaders throughout the District. Each year, CLIP brings together a group of Classified Professionals from across the District to network and learn from each other, identify professional development opportunities for the cohort, and develop and implement projects that will support Classified Professionals across the District and, as a result, support the work of the colleges.

VC Fong stated his favorite part of his job this past year has been working with the Classified Leadership Institute for Professionals, CLIP by watching the two colleges and the District work together.

VC Fong presented an award to each recipient: Mr. Jesus Bravo-Morales, Ms. Linda Bwellina, Ms. Talice Dennis, Ms. Deborah Dobbins, Mr. Timothy Druley, Ms. Sarah Flores, Ms. Philomena Franco, Ms. Yvette L. # 2.1 PRESIDENTS OF CHABOT AND LAS POSITAS COLLEGES FACULTY SENATES

Las Positas Academic Senate President, Ms. Sarah Thompson reported on the following items:

She reported the senate goals for 2019-20:

  - Work with district and college committees to identify priority needs while maintaining necessary reserves

  - Work towards better paths not just for individual disciplines, but across discipline lines

- 6. Brown Act/Roberts Rules Orientation
  - o Training, Standardization, and AB2257 compliance
- 7. Explore a "District Plenary"
  - o Effective communication in multi-college districts
- 8. Resurrection of LPC Olympics

She thanked VC Fong for orientating hiring committees, and past President Dr. Barry Russell for having diversifying throughout the campus. She stated they are struggling with their part time faculty as they do not have the level of diversity as their full time faculty which will take some exploration over the years to find solutions. Lastly, she stated she is looking forward to a great year.
