

MODIFICATION TO AGREEMENT

FOR

Reference is made to Professional Services Agreement made and entered into by and between Chabot-Las Positas Community College District and LPAS, Inc. hereinafter referred to as the "Architect/Engineer" having its principal place of business at 2484 Natomas Park Drive, Suite 100, Sacramento, CA 95833 and Chabot-Las Positas Community College District, hereinafter referred to as the "District", dated March 4, 2019.

This Modification Number One (1) to Agreement B190311: B2100 Design and Engineering Services

SCOPE:

Services to the above reference Agreement shall include, but not limited to, the following specialty consulting:

• Provide Architect/Engineer shall provide the design and other services described in Agreement B190311 appendix A.

TERM OF AGREEMENT:

In accordance to the Agreement for Professional Services Agreement, dated March 4, 2019; per the contract Article 5, the fee is a lump sum identified as \$5,652,250.00. Also, according to the contract Article 5.5, this fee shall be full compensation for all of Architect's work, including but not limited to... any other direct or indirect expenses incident to providing the services.

Per the RFP; the cost identified as 'Additional Project Related Costs' of \$200,000, is a lump sum fee. This modification will amend the "Reimbursable Expense" itemized in Exhibit D.A.2 as a 'Lump Sum Additional Project Related Cost' and will be invoiced to match the percent completed for each phase of the contract as outlined in Exhibit D. As such, there would be no additional reimbursable expenses invoiced for the project; as they are accounted for in these costs.

<u>FEE</u>:

The lump sum, Not-To-Exceed fee for these services remains unchanged per the contract Agreement. The Additional Project Related costs will be billed to the following schedule:
