1.9 APPROVAL OF MINUTES OF JUNE 15, 2021, REGULAR MEETING

1.10 PRESENTATION: 2021-2022 ADOPTED BUDGET: GENERAL FUND, CAFETERIA FUND, CHILD DEVELOPMENT FUND, CAPITAL PROJECTS FUND, SELF-INSURANCE (RUMBLE) FUND AND MEASURE B FUND

Chancellor Gerhard introduced Vice Chancellor Nicholas who gave the following presentation. VC Nicholas stated the 2021-2022 Adopted Budget will be reviewed this evening and voted on at a subsequent meeting for official approval. He recognized VP Raichbart at Las Positas and VP Wagoner at Chabot, and Ms. Roque and Ms. Bishop from the District office for their hard work.

ADOPTED BUDGET OVERVIEW

- Unrestricted fund balanced districtwide and, most importantly, at all sites
 - o Surplus of approximately \$6.5M or about 5.3% of the expenditure budget
 - o Surplus achieved through a combination of factors:
 - Cost-living adjustment of 5.07%
 - Unfilled vacancies
 - Reliance of federal stimulus dollars where appropriate
 - Hold harmless funding of \$9.1M
- Projected Ending Fund Balance of \$25.5M
 - o Equates to a reserve level of 20.63%, well above the 8% target reserve in AP 6305
 - As we continue the FY 2020-21 closing process, this figure can and likely will shift, perhaps significantly, by the 311 Annual Report in October.

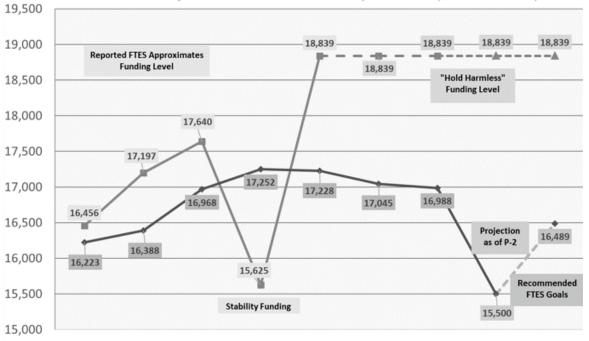

HOLD HARMLESS FUNDING

- The unrestricted fund budget is partially balanced through the recording of the Hold Harmless revenue of \$9.1M
 - This is not distributed through the revenue allocation model
 - Results in negative reserves at the sites and a large districtwide reserve to counter those effects
 - Currently looking at resolving this reserve issue should the district migrate a new Budget Allocation Model
- Hold Harmless funding is secure through fiscal year 2024-25, with the extra year being added in the latest state budget

Questions:

Trustee Maduli stated as one trustee he has been the most critical of the district in terms of the budget since joining the Board in 2016. He stated he is encouraged with the budget that VC Nicholas presented. He stated it is the first time that all four sites are balanced in the fiscal year of the budget however we are not there yet. He referenced slide number 17 stating all four sites have come up with a surplus in terms of its ending balance and we are seeing how that is helping out with the carryover deficit. He stated when you look at Las Positas College it has a positive ending balance but it had a deficit carryover. He stated the reason why he is hopeful is with the Allocation Model being reviewed and perhaps it coming to the Board prior to the budget development for 2022- 2023 we can fix these problems in terms of the deficits. He stated he applauds VC Nicholas on the volume of the report and including the three agencies and the standard fours.

Trustee Maduli complimented Chancellor Gerhard and VC Nicholas for working to establish the OPEB liability and irrevocable trust.

Trustee Granger asked if one-time money was used to show a net positive for all locations. VC Nicholas stated yes, stimulus funding is covering that. Trustee Granger stated that the presentation reminded her of all the work and advocacy that staff has done with the SCFF and hold harmless to get us here. She recognized and appreciated the collaborative effort that has been made by the colleges and the district to work together to recognize that our budget allocation model needs to be revised and that while we have a balanced budget this year, we know there is work to be done to continue on this path.

Trustee Sbranti stated it is encouraging to see the positive momentum we are making but recognizing that there is a lot of one-time dollars there and hold harmless. He stated even though there are some encouraging signs maybe there will be some movement there that is more permanent year over year. He stated we need to

operate with the mindset that we do have a structural deficit that needs to be addressed so we are not relying on those one-time dollars. He stated it is encouraging the progress that has been made and if we operate in that mindset and close those structural gaps I think we will be in good shape. He stated he is encouraged with the OPEB liability in bringing it down. He thanked the staff for their hard work and effort.

Trustee Heredia acknowledged the revision of the allocation model.

President Randolph thanked VC Nicholas for his presentation. She stated the numbers look good however, there is still work to be done. She thanked the college presidents and staff for their continued work the managing the budget.

1.11 PRESENTATION: JOINT RESOLUTION ON LGBTQ+ INCLUSIVITY

Chancellor Gerhard stated this presentation is something to be celebrated. He introduced Academic Senate President Mr. Miguel Colon who gave the presentation.

Mr. Colon stated the senate has been working on this for several months and they are excited to be presenting something that will "survive us". He stated the work on the Resolution started by a student sending a simple email asking how a name can be changed in Canvas. He stated he discussed this with his senators and discovered this was a bigger issue then they initially thought. He stated following the meeting they formed a committee that was led by senators Ms. Abdoun, Ms. Ashraf and Ms. Paiz. He stated the committee developed the resolution not only addressing technical issues as well as mental health issues. He stated their LGBTQ population is the single largest demographic group on campus. He stated the resolution was unanimously adopted by the academic, classified and student senates. He stated he has been working with Las Positas Senate President Ms. Thompson to collaborate on making a joint resolution that will be more impactful. He stated Ms. Thompson, Ms. Young and Mr. Katile joined the committee and created a joint committee that developed three resolutions that was broken into three pieces; faculty, college and district. Ms. Abdoun, Ms. Ashraf and Ms. Paiz read the resolution.

Mr. Colon stated the next step will be for the resolution to be presented at Chancellor's Council where a Board or Administrative Policy will be developed and adopted then brought back for Board's approval. Lastly, he stated this product demonstrates how well the two colleges work together.

Trustee Heredia thanked everyone for acknowledging the needs of our students.

President Randolph thanked the presenters. She stated it is such a good feeling as an individual Trustee to be A part of a community college district that cares so much about our students. She stated as a former teacher She used the quotation, "you be you" and everyone at our colleges have proven this to our students, "you be you".

Mr. Colon welcomed and congratulated Chabot College Classified Senate President, Ms. Heather Hernandez and welcomed back Chabot College Student President Senate, Ms. Theresa Podesto. He stated Ms. Paiz received the Excellence in part-time Faculty award. He stated this award is funded by the faculty.

Las Positas College Academic Senate President, Ms. Sarah Thompson stated the following:

Ms. Thompson acknowledged the presenters of the Joint Resolution on LGBTQ+ Inclusivity and stated it was wonderful to collaborate with Las Positas and looks forward to incorporating the college recommendations that have come out of the resolution for the faculty. She stated today the senate received Brown Act training. She stated they are trepidatious regarding the upcoming September 30th deadline; in continuing to conduct public business on zoom. She stated Mr. Miner, welding instructor received the Teacher of the Year award, Mr. Jeff Judd, part-time biology professor received the Outstanding Service award and Ms. Ruth Hannah, 30-year faculty veteran received the Reed Buffington award.

Senate Priorities AY 21-22

- Engage classified professionals in the decision-making process through thoughtful participation, and leadership, in college and district governance structures.
- Strengthen standards, policies, procedures, and practices that support student and classified success and equity.
- Enhance classified professional knowledge and roles in the areas of institutional planning, budget, and accreditation.

Recent Classified Senate Business/Activities

- Approved 21-22 senate priorities, and objectives to meet those priorities, at the August 13 meeting.
- Held Classified Senate Retreat on July 29, 2021. We had 30+ members present for training on shared governance and Classified Senate business for the upcoming year. Thank you to our planning team: Virginia Criswell, Christine Herrera, Terra Lee, Sarah Flores, Nicole Albrecht, Rachael Tupper-Eoff, and ShelleyRae Corpus.
- Hosted guest speaker, Secret Brown, on leadership and on moving from "surviving to thriving," at the July 29 senate retreat. The event was open to all classified campus-wide and was sponsored by the Classified Professional Development Block Grant and senate co-curricular funds.
- Co-hosted a convocation day session with the LPC Classified Senate President for 55+ Classified District-wide. The session focused on self-care and best practices as we transition to more in person services this semester.
- Continuing to appoint classified seats on college and district shared governance committees.
- Formed a small workgroup to review the District's Injury and Illness Prevention Plan.
- Consulting with SEIU to fill represented classified seats on hiring committee panels per district hiring procedures for classified professionals and administrators.

2.3 PRESIDENT OF STUDENT SENATE OF CHABOT AND PRESIDENT OF ASSOCIATED STUDENTS OF LAS POSITAS COLLEGE

Chabot College Student President Senate, Ms. Theresa Podesto stated the following:

Ms. Podesto stated they had their retreat August 7th where they reviewed the Robert's Rule of Order, learned about shared governance and assigned committees. She stated they have received a few hundred responses from the survey on mandating the vaccination. She stated Gladiator Day is scheduled in-person for August 24th. Lastly, she stated the student senate will collaborate with the LPC student senate pm a joint resolution mandating smoke-free campus and mandating the vaccination.

Las Positas Student President Senate, Mr. Kyle Johnson reported on the following items:

Mr. Johnson stated the Market was cancelled due to scheduling conflicts with College Day. He stated at their last meeting, student government approved to meet Mondays at 2 p.m. He stated during Convocation he had the opportunity to meet with Chabot Student Government President Ms. Podesto. He stated they will be meeting monthly to align their goals for the benefit of the students. Lastly, he thanked everyone that worked on the LGBTQ+ resolution.

GOOD OF THE ORDER

Ms. Rachel Ugale, Chapter President SEIU, reported on the following:

Ms. Ugale stated she is happy to report an agreement has been made with the district on the return to work language. She thanked the work of the chapter leadership team for fighting for language that represents the needs of the unit members. She stated reflected in the agreement is language around vaccination, COVID testing, access to PPE, leaves of absence and the ability for members to go on walkthrough of their work areas prior to returning to the office and with follows a transition period, encouraging a hybrid workplace model and the ability to telecommute as needs allow. She stated they presented the agreement during Convocation during their general membership meeting yesterday and the majority of the members were supportive. Lastly, she stated Mr. David Rodriguez was recently sworn in as Treasurer.

Mr. David Fouquet, President, Chabot-Las Positas Faculty Association, provided the following report:

Full-Time Hiring — Our District's share of the \$100M allocated statewide is a little over \$1.6M ongoing, which we'll use to hire 18 new Full-time faculty. (Always a bell worth ringing: Advocacy by such entities as FACCC and CCCI were instrumental in getting this allocation in the budget.) It's important to note that our Full-time Obligation Number (FON) has decreased quite a bit during the pandemic, as a result of declining enrollments. While 18 new Full-time faculty won't get us back to where we were, pre-Covid, it *will* increase the proportion of classes taught by Full-time faculty—which is precisely what the funding is intended to do.

COVID-19: No doubt it's redundant to report, the delta variant has been a hot topic of conversation among faculty during Convocation. Of immediate concern is how to ensure the safety of faculty who stepped up to work on our campuses this Fall— many of whom are now feeling uneasy in the wake of Delta. A larger, looming concern is how to plan effectively for Spring '22. There's no question that we need to re-establish vibrant on-campus operations, but many factors remain unknown. We have, however, heard from a number of faculty who say they won't feel safe working on campus unless all staff & students are vaccinated.

Needless to say, should the District elect to issue a vaccine mandate, the FA stands ready to negotiate impact effects for faculty.

4.1 APPROVAL OF LETTER OF PARTNERSHIP FOR EAST BAY COLLEGE AGILE NETWORK (EBCAN) INITIATIVE BETWEEN CALIFORNIA STATE UNIVERSITY EAST BAY AND CHABOT LAS POSITAS COMMUNITY COLLEGE

Trustee Sbranti asked that this item be pulled from the Consent Calendar. Trustee Sbranti asked if there is an opportunity for Cal State East Bay courses to be taught at CLPCCD facilities. VC Fleischer Rowland stated it has often been in context, since executive leadership came together in spring 2020 to craft a deeper partnership between our district and the university; which is our top transfer destination. She stated yes, there has been discussion about upper division courses being taught on our campuses so our students can see their educational goals reached baccalaureate and stay on our home campuses. She stated they realize there is a gap in the region when students leave Cal State East Bay however, safety nets are being created for referrals for those students to attend at Chabot or Las Positas. Trustee Sbranti stated the possibilities of collaboration with our faculties directly opens doors for our students. He stated we could do something similar with UC Merced that would bring so much benefit to our students. Lastly, he thanked everybody involved with this.
