FIRST AMENDMENT TO COOPERATIVE AGREEMENT NO. 21-PUENTE-CC-61 between THE REGENTS OF THE UNIVERSITY OF CALIFORNIA on behalf of THE PUENTE PROJECT and CHABOT-LAS POSITAS COMMUNITY COLLEGE DISTRICT on behalf of

LAS POSITAS COLLEGE

This First Amendment to the Cooperative Agreement No. 21-PUENTE-CC-61 executed by the parties effective <u>August 23, 2021</u> ("Cooperative Agreement"), is by and between The Regents of the University of California ("**University**"), on behalf of UC Berkeley's Center for Educational Partnerships' ("**CEP**") Puente Project ("**Puente**") and the **Chabot-Las Positas Community College District** on behalf of **Las Positas College** ("**Recipient**") and is effective as of the date of the parties' final signature below.

The parties hereby agree as follows:

A. Section 3 (Award Amount and Financial Accounting), Paragraph A of the Cooperative Agreement shall be deleted in its entirety and replaced with the following:

The University will provide one time funding of \$2,500 for July 1, 2021 – June 30, 2022.

The University will provide operating funds of \$50,000 to support the implementation of Puente Math and Science Program (Puente MÁS) for July 1, 2022 – June 30, 2023.

If sufficient funds are not appropriated by the State of California for this program, or if funding for any fiscal year is reduced or deleted, this Agreement shall either be cancelled pursuant to the applicable Agreement termination provisions or amended to reflect a reduction in funds.

B. Exhibit A, Section I (Responsibilities of the Recipient), Paragraph A (Training & Field Trip Days), Item 1 of the Cooperative Agreement shall be deleted in its entirety and replaced with the following:

Recipient shall offer a two-semester course sequence consisting of transfer-level English courses and a transfer-level math course in the fall and/or spring semester(s) of 2022-23 terms for the designated cohort of Puente students who enroll in the courses as part of the Puente Program and as outlined in the Puente Community College Program Implementation Guidelines.

C. Exhibit A, Section I (Responsibilities of the Recipient), Paragraph C (Staffing) shall be amended to add additional language and be referred to as item 4:

4. Recipient shall also select and hire one or more full-time Math Instructor(s) whose schedule enables them to serve as a full team participant. The Math Faculty shall be assigned to the Puente class and shall also receive reassigned time for Puente co-coordination and participation in Puente trainings in the fall and spring semesters.

All other terms and conditions of the Cooperative Agreement shall remain in full force and effect.
