- Risk Management considerations if you choose to make homemade hand sanitizer:
 - Individuals may have a potential allergic or adverse reactions to the hand sanitizers.
 - o Employ the advice/assistance from individuals who are knowledgeable in chemical formulas and compounds to ensure the appropriate and most effective formula is concocted.

- O Advise through signage that the use of the formulated hand sanitizer is at their own discretion and that individuals are encouraged to wash their hands with soap and water instead of the hand sanitizers.
- O Explain through signage that the district/agency is unable to access or purchase hand sanitizer and has formulated this in an effort to provide this as an option.
- o Provide labels with the ingredients used in the formula and first aid instructions in the event of allergies, adverse reactions or consumption.
- O Consider limiting the use of the hand sanitizer to staff, adult visitors and middle school aged students or older.
- Due to the alcohol content of the hand sanitizers, there is a potential risk for using it as a fuel source for fire and a risk of consumption.
 - O Limit access to the hand sanitizer in areas where there is an adult to supervise its use. Potentially put it in areas where students would need to ask to use it.
 - o Consider limiting the use of the hand sanitizer to staff and adult visitors only.
- As you are exploring and weighing your options, here are some ideas for reminding students of appropriate hand washing practices:
 - o Encourage and communicate proper hand washing techniques.
 - Elementary school aged students have teachers incorporate a quick reminder at the start of
 classes on practices to prevent the spread of germs and viruses cough and sneeze in your elbow,
 avoid touching your face, wash your hands, etc.).
 - o **Middle school/High school aged students** encourage fun learning modalities i.e., create a video competition for raising awareness around illness prevention.

Guidelines for determining if a COVID-19 exposure is OSHA recordable and reportable

- COVID-19 is considered a recordable illness (OSHA 300 log) if it occurred from the workplace (as opposed to the common cold/flu) https://www.osha.gov/SLTC/covid-19/standards.html
- If it is determined that an employee became ill from COVID-19 as a work-related illness, then the employer will need to adhere to the current triggers of when to report serious illnesses and deaths to OSHA:
