Q. Where can I find information about Bid No. B20/21-09?

Q. What is the scope for this project?

A. The project is limited to interior work in the information Desk, Counseling Services, Financial Aid, and Admission and Records. The Information Desk and Counseling Services are located in the East Wing of the First Floor. Financial Aid and Administration and Records are located on the East Wing of the Second Floor of the Las Positas College Student Services and Administration Building (B-1600 DSA#01-11019). The improvements to the Information Desk include the projection of ADA counter for front approach, the replacement of the grille curtain coiling for a solid curtain, installation of fixed glass panel across the opening, and addition of a mail slot. The improvements to the Student Services Areas include the projection of ADA counters for front approach, replacement of the sliding glazed system with fixed transaction windows, and construction of acoustic dividing fin wall between transaction bays.

Q. What is the Engineering Estimate for this project?

A. The estimate for the Las Positas College - Students Services Interior Improvements project is \$484,000.00
