

# Chabot-Las Positas Community College District Chancellor's Council

Meeting Minutes

Chancellor Ron Gerhard called the meeting to order at 3:00 p.m.

# I. Review and Approval of Agenda The agenda was approved as presented. (Johnson/Pedrosa) All in favor.

II. Review and Approval of the November 9, 2021 Meeting Minutes
There was a motion to approve the November 9, 2021 meeting minutes.
(Pedrosa/Johnson) Abdoun and Kutil abstained.

# III. COVID Update

OLetcher gave an update from the Alameda County. We slid backwards to a substantial tier. The case rate per 100,000, hospitalization rates remain down. Our vaccination population number is rising currently one dose is above 83%, and a 2-dose vaccine is in the 75-76% range. There is no change to the masking requirement. The next likely change will be December 29<sup>th</sup>. CDC guidelines have changed as of November 15<sup>th</sup> for fully vaccinated workplaces, which removes social distancing requirements and some other pieces.

RGerhard shared the Alameda County Health Department data. It can be found at Covid19.cagov.org. The case rate table was shown, which helps inform the county's changes in their directives. The 14-day case rate was a little over 1400 cases. We have come down from the August Delta variant surge.

OLetcher mentioned that this week, the CDC published an update on the Omicron variant and it is currently tracking as contagious to the levels of the Delta variant, but likely symptoms being lower and lower hospitalization rate and severe illness and death rates. We continue to track CDC information. Their recommendations are the same as the Delta variant. Fully vaccinated people now remove the social distancing requirement, but if you are a higher risk, they recommend social distancing and a N-95 mask. DFouquet mentioned that it has been in the news that the omicron variant is spreading at least twice as fast as the delta variant in South Africa. OLetcher mentioned that the Delta variant was not the predominant variant in South Africa, it was the Alpha variant.

RGerhard mentioned that we have about 7,000 students that have uploaded their proof of vaccination within Cleared4 and have received the blue passes and can start registering for face to face classes. Communications to students continue to go out. We have reached 40,221 students.

RGerhard showed a spreadsheet of student enrollment trends. At Chabot, 31% of the course offerings at Chabot are offered in an online format. The remaining 69% are being offered face to face or in a hybrid modality. Of the 1800 FTES, it is evenly distributed between online courses and the face to face or hybrid modality. The numbers show an increasing number of our enrollments, enrolling in face to face or hybrid classes. It took students a bit of time to get through the Cleared4 process. DFouquet mentioned that there may be some additional cold feet because of the news about Omicron. There could be an impact on the desire or willingness for students to take face to face classes. RGerhard hopes that information will be available on the efficacy of the vaccine's efficacy against this variant. MAbdoun mentioned that there is some fear from the faculty that the face to face classes are not filling. If the trend continues, are we able to shift some of those classes to online of hybrid classes? RGerhard stated that the VPIs and Presidents will really inform that within the CEMC meetings. That along with other options would be considered. The positive is that the percentages have increased since November 17th. CKutil mentioned that we have to have a presence on campus somehow. RGerhard stated that we are looking at similar data as it relates to this fall term. The reality is that at Chabot, we have about 230 sections that have less than 15 students in those classes. At Las Positas, we have a little more than 120 sections that have less than 15 students in the class. There are reasons why some lower enrolled classes are not cancelled or altered.

RGerhard showed a similar report for Las Positas College. At about 62% of the FTES are in sections that are being offered in an online format and about 38% are face to face or in a hybrid modality. CKutil asked about the headcount change from 11/29 and today. There is not a significant change from 11/29 and now.

Students no longer have to go into Zone mail. They can use a specific URL link with Cleared4 and still maintain the security parameters necessary. Next week, we will have the real credible data and see if there is a bump in enrollment, like we have seen in Cleared4 submissions.

#### IV. Board Policies/Administrative Procedures (standing item)
