# Agenda 3. College Enrollment Updates – Chabot College and Las Positas College Time allotted | 10 mins |

- **3a**. Jeff Drouin reported that enrollment for Chabot College is down slightly, but the college is optimistic. Next, he mentioned an issue with their schedule being completed as his division was not in the printed schedule and will be corrected to view online.
- **3b.** Tom Orf reported enrollment for Las Positas College is up and believes the increase is from seeing students through the entire process from Counselors to registration.

# Agenda 4. State Enrollment Reports – Jonah Nicholas Time allotted | 10 mins |

# **Discussion**

Jonah announced that the Statewide data enrollment P2 report had yet to be published and mentioned that districts are up spring over spring, similar to what Chabot-Las Positas Community College District (CLPCCD) is experiencing. CLPCCD recently reported its P2 numbers with 12,563 FTES. Jonah shared his screen to show where CLPCCD is trending for the academic year 2022-2023. Analysis of the SCFF metrics indicated CLPCCD is down almost 900 FTES on the credit side year over year. That is, in 2021-2022, credit FTES was 13,353, and in 2022-2023 credit estimated FTES was 12,471, indicating a -6.64% decline. Disaggregated data indicated the Cal Promise grant had a -6.64% decline, AB540 with a decline of -17.25%, and a -6.64% decline for Pell. We are tracking what FTES and other metrics will be needed to get off hold harmless. Jonah indicated a good number to consider is 15,500 FTES on a 3-year rolling average. In law, hold harmless goes away in the academic year 2025-2026. In the case of CLPCCD districts will not sustain a loss of funding, however, the consequence is no COLA. The incentive is there for every community college district to meet the SCFF metrics.

Agenda 5. Are You Up to Date on ITS District-Wide New Systems? – Theresa Fleischer Rowland

#### Discussion

Bruce Griffin provided a presentation on My Portal and CRM Advise. He indicated that My Portal is in ongoing development, and CRM Advise will go live at the end of May 2023 with ongoing development. Next, he explained that My Portal / Single Sign-On would eventually replace Class Web as more people opt-in; currently, about 13% of students have opted in. The plan is to get more people to sign in and use the system which will result in a workload reduction for the campuses, i.e. single sign on addresses lockouts, and forgotten passwords. Bruce provided a demo of the Single Sign-On, showed the cards displayed on My Portal, and explained how the cards might be customized. He then explained CRM Advise, a Constituent Relationship Management software focusing on student retention through engagement. CRM

Advise facilitates automated communication with students, the work now with collaborators is on the messaging and timing of sending out key communications to enrolled students. CRM is an Ellucian product, and therefore integrates with Banner.
