- First, consider what has happened over the last two years in Northern California.
- How Emergency Management is organized:
 - Preparedness
 - Mitigation
 - Response
 - Recovery

The Emergency Management Program

- Emergency Management
 - Preparedness
 - Planning
 - Emergency Operations Plans - **everything that follows is in the EOP**
 - Chabot College & Las Positas College – larger and more specific documents
 - **Incident Command**
 - District Office – smaller umbrella
 - **Emergency Operations Center (EOC) management**
 - Agency Relationships
 - Cities
 - County
 - BAUASI (Bay Area Urban Area Security Initiative)
 - State
 - VOAD agencies (Voluntary Organizations Active In Disaster)

The Emergency Management Program

- Emergency Management (cont.)
 - Preparedness (cont.)
 - Training
 - DSW – NIMS/SEMS/ICS
 - ICS Section Training – **Command/Management, Operations, Planning, Logistics, Finance**
 - Building Monitor/CERT Training (College Emergency Response Training)
 - Shelter Operations Training – American Red Cross & ALCO Public Health Department
 - Drills & Exercises
 - Evacuation Drills – two minimum every year
 - Tabletop Exercises – 2019-2020 six total – two per college & two at the District Office
 - Shelter Drills (TBA)
 - Functional & Full-Scale Exercises (TBA)
 - Supplies & Equipment – standardized annually in the District Office budget

The Emergency Management Program

- Emergency Management (cont.)
 - Mitigation
 - Non-Structural Earthquake Hazards
 - Aviation hazards at Chabot College
 - CPTED – Crime Prevention Through Environmental Design
 - Security Master Plan implementation
 - Response
 - Notification/Activation – Everbridge
 - Unified Command
 - PIO Development
 - Damage assessment
 - Search & Rescue
- Emergency Management (cont.)
 - Response
 - Communications
 - Everbridge
 - EBRCSA (East Bay Regional Communications System Authority)
 - Satellite phones
 - Phones, cell phones, text messaging
 - Amateur Radio
 - Disaster Medical
 - Sheltering
 - Staging
 - **AFN – Access & Functional Needs**

The Emergency Management Program

- Emergency Management (cont.)
 - Recovery
 - Disaster Mental Health Services
 - Incident Specific
 - Increased emphasis for criminal incidents, i.e. shootings and acts of terrorism
 - Continuity Of Operations Planning (COOP)
 - The colleges need to be back in business as rapidly as possible
 - Plans must anticipate potential scenarios ahead of time
 - Power grid, transportation infrastructure, building damage, alternate locations, etc.
 - Cost Recovery
 - Mastering the intricacies of recovery funding from the State & FEMA (and other federal agencies)
 - Elected Officials training – our Board, city councils, board of supervisors, etc. – this must be collaborative

The Safety Program

- Comprehensive Safety Program

- Plans – There are two:

- Emergency Action Plan (EAP) – OSHA
 - Injury & Illness Prevention Plan (IIPP) – Cal OSHA

- Procedures

- Work Environment – Cleanliness, equipment maintenance, ergonomics
 - Work Practices posted conspicuously – “always...”, “never...”
 - Code Compliance
 - Disaster Response – what do we do in specific places like science labs and auto shops?

- Safety Data Sheets (SDS) – purchasing process, current inventory with database, Keenan input and guidance

The Safety Program

- Comprehensive Safety Program (cont.)
 - Training
 - Documentation
 - Long range training schedule – FA/CPR/AED, et. al...
 - Inspections – enact a schedule: Annual, Semester, Weekly, Daily
 - Incident Review Group – a simple question: can we make our workplace safer by reviewing incidents and proposing recommended improvements?
 - Communication & Coordination With External Partners
 - Local fire departments
 - HAZMAT responders
 - Alameda County Department of Environmental Health
