Approval of Cooperative Agreement—The Regents of the University of

California, Puente Project No. 12-CCC Puente-04, Chabot College

<u>Background</u>: The mission of the Puente Project is to increase the number of educationally underrepresented students who enroll in four-year colleges and universities, earn degrees, and return to the community as leaders and mentors to future generations. The first Puente Project was initiated at Chabot College in 1981. Since that time, the model has been replicated at 59 colleges and 34 high schools throughout the State of California, with the oversight of the Puente Project centralized through the Regents of the University of California.

The Puente Project at Chabot College will provide instruction and services including counseling, mentoring, and follow-up to meet the mission of the program. The agreement outlines the continuation of staffing and office and administrative support currently offered by Chabot College. The Regents' Puente Office will provide staff development programs at no cost for instructors and counselors participating in the project. Additionally, the college will provide the student and college data necessary to conduct ongoing program assessment including student outcome data analysis to determine the impact of the Puente Project.

This cooperative agreement shall be in effect for the period July 1, 2012 to June 30, 2013.

The Board of Trustees approved MOU renewals on August 16, 2005 under item 4.1, August 22, 2006 under item 4.3, October 16, 2007 under item 4.5, and June 24, 2008 under item 4.5. The 2009 document changed from a MOU to a cooperative agreement. On November 17, 2009 under item 4.1, and March 15, 2011 under item 4.4 cooperative agreements were renewed.

Approval of Cooperative Agreement—The Regents of the University of California, Puente Project No. 12-CCMUL Puente-03, Las Positas College

<u>Background</u>: Newly established project between the University of California and Las Positas College. The mission of the Puente Project is to increase the number of educationally underrepresented students who enroll in four-year colleges and universities, earn degrees, and return to the community as leaders and mentors to future generations. The first Puente Project was initiated at Chabot College in 1981. Since that time, the model has been replicated at 59 colleges and 34 high schools throughout the State of California, with the oversight of the Puente Project centralized through the Regents of the University of California.

- This is a six year agreement from July 1, 2012 to June 30, 2018.
- During the first three years of this agreement (2012–2013, 2013–2014, 2014–2015) the Puente Project will provide of \$30,000 for capacity building funding per year and \$5,000 for operational costs per year.
- During the final three years of this agreement (2015–2016, 2016–2017, and 2017–2018) Las Positas College shall contribute, from its own or third-party resources, program operating costs at a minimum of \$5,000 for expenditures.

The reason for the lateness of this Cooperative Agreement is due to the fact that the documentation was not received from the University of California until September 7, 2012.

Approval for Travel Study Program-"Faces of Cuba" and Agreement with

Global Exchange Reality Tours, Chabot College

<u>Background</u>: In accordance with Board Policy 6217, Travel Study Programs, a course has been designed that involves travel and studies abroad. "Faces of Cuba" travel study has been immensely popular. This course will be offered during Winter Break, January 4 through January 17, 2013 as a one (1) unit course. The History discipline supports and affirms the importance of travel studies in Program Reviews.

The cost per participant for the Cuban travel studies program is approximately \$2,750.00, based on a minimum of 20-25 participants, excluding airfare. The program includes accommodations, guides, ground transportation, activities and meals. A deposit of \$1,000 is required with application and final payment due 45 days in advance of travel.

Course studies examining Cuba are relative to the disciplines of history, anthropology and archaeology. Participants will gather information through direct and participatory observation. Moreover, the contemporary issues facing the United States today surrounding immigration and international relations are extremely relevant for our students and the communities we serve.

The Board of Trustees previously approved travel agreements with Global Exchange Reality Tours to Cuba on October 18, 2011 under item 4.3, May 17, 2011 under item 4.4, Mexico on February 19, 2008 under item 4.3 and 4.4, February 24, 2004 under item 4.5 and 4.6, August 19, 2003 under item 4.1, October 15, 2002 under item 4.7, September 18, 2001 under item 4.3, March 20, 2001 under item 4.4 and August 15, 2000 under item 4.2.

Recommended Action: That the Board of Trustees approves the proposed travel study program, "Faces of Cuba" and the agreement with Global Exchange Reality Tours, Chabot College, for travel during Winter Break, January 4 through January 17, 2013. Acceptance of Memorandum of Understanding (MOU) Agreement – Hayward

Promise Neighborhood Program with Hatchuel Tabernik and Associates,

Chabot College

Background: This Memorandum of Understanding (MOU) with Hatchuel Tabernik and Associates (HTA) in support of Chabot's Hayward Promise Neighborhood (HPN) subaward agreement with California State University, East Bay (CSUEB), delineates the data sharing responsibilities of each party and ensures the confidentiality of student data in support of Promise Neighborhoods planning activities. The MOU also includes the data request which details the data to be shared. HTA is a consulting firm that is responsible for conducting the grant program evaluation, collecting formative and summative data from project participants and from project partners, analyzing summative data, and evaluating HPN's progress with meeting grant outcomes for the CSUEB Hayward Promise Neighborhood Implementation grant. Their services are being paid by CSUEB with grant funds.

The MOU is part of a U.S. Department of Education Promise Neighborhoods implementation grant that CSUEB received in January 2012 and Chabot's subsequent execution of the subaward agreement in April 2012. Grant funds pay for project activities with CSUEB and multiple partners as part of the Promise Neighborhoods Community of practice to build a cradle-to-career continuum of solutions that targets an under-served neighborhood in Hayward. Partners include the City of Hayward, 4C's of Alameda County, Eden ROP, Hayward Unified School District and Hayward Public Library.

Recommended Action: That the Board of Trustees accepts the proposed Memorandum of Understand (MOU) with Hatchuel Tabernik and Associates, Chabot College for the period April 24, 2012 through December 31, 2016. Any future augmentations or amendments must be made in writing according to the conditions of the MOU agreement. No. P335A090192-12, Chabot College

<u>Background</u>: Chabot College is in the fourth year of a four year grant from the U.S. Department of Education Program, Grant Award No. P335A090192-12.

The Child Care Access Means Parents in School (CCAMPIS) grant is used to support campus-based child care designed to serve the needs of low-income students and to enable them to pursue postsecondary education at both Chabot College and at the California State University, East Bay. These funds benefit families and children by strengthening the quality of the Child Development program through re-engagement in the National Association for Education of Young Children (NAEYC) accreditation process, increasing collaboration between the College's Early Child Development (ECD) faculty and Child Care staff, and improving the quality of instruction. CCAMPIS activities will ensure quality care practices that have significant correlations between quality care and retention of student-parents.

Year four of the four-year grant has been awarded in the amount of \$43,681 for the period October 1, 2012 through September 30, 2013.

College District for Partnership on California Acceleration Project, Chabot-Las

Positas Community College District

Background: The Chabot-Las Positas Community College District (CLPCCD) is currently leading a statewide curricular reform effort designed to increase completion rates among basic skills students. The initiative, The California Acceleration Project, supports community college faculty across California's 112 community colleges to redesign their English and Math curricula. Funding is provided through grants from the Walter S. Johnson Foundation, the Foundation for California Community Colleges/LearningWorks, the Community College Research Center (all previously approved by the Board), as well as ongoing support from the California Community Colleges' Success Network (3CSN), part of the state chancellor's office's basic skills initiative.

This agreement is for CLPCCD/Chabot staff to develop and deliver the California Acceleration Project in partnership with Los Medanos College. Lead English instructor at Chabot College is Dr. Katie Hern; grant administrator at Chabot College is Dr. Marcia Corcoran, Dean of Language Arts. Lead Math Instructor at Los Medanos College is Myra Snell.

The current Memorandum of Understanding is an extension of a previous MOU for the 2011-12 year. The current MOU is for \$47,641 to cover activities of Lead Math Instructor from August-December 2012 for \$30,833 and for January-June 2013 for \$16,808, totaling \$47,641. The delay in Board submittal is due to awaiting prior approval by the Contra Costa Community College District Board.

Program, Agreement No. CN110123 with the San Francisco Community

College District, Las Positas College

<u>Background</u>: The California Early Childhood Mentor Program started at Chabot College in the late 1980's. Las Positas College joined the program in 2001. Since its inception, it has been a highly successful program in promoting both the retention and quality of teachers of young children.

The regional program requires individual agreements between the participating colleges and the San Francisco Community College District, the fiscal agent for the Statewide Mentoring Program.

The agreement is for the period of August 1, 2012 through July 31, 2013.

Background: A food services committee was formed comprised of students, faculty, classified staff and management to evaluate the Las Positas food services providers and catering for the management/operation of the Las Positas College Food Service at the New Student Services and Administration Building. The various concerns surrounding alternative food selection, safety, service and the food program were reviewed and discussed by the committee prior to the release of the solicitation on June 25, 2012 for the Request For Proposals (RFP) No. C-12, Food Services, Las Positas College with responses due August 23, 2012. A total of seven (7) firms attended the mandatory walk resulting in three (3) proposals submitted to the District for review of procurement guideline compliance. In addition, the committee conducted site visits, scored the demonstration of catering skills and interviewed the firms.

The recommended committee results determined that the projected five (5) year revenue from the Food Services Operations to Las Positas College based on projected sales were:

Fresh & Natural Food Service Group, Milpitas, CA	\$217,113.45
Taher, Inc., Minnetonka, MN	\$147,845.38
Elite Food Services, Inc., Hayward, CA	\$140,671.07

Fresh & Natural Food Service Group currently operates the Chabot College Food Service program. The new agreement will guarantee a higher level of annual commission and includes other compensation, catering and planned improvements over and above current levels.
