Approval of Salary Schedule Increase and Tax Sheltered Annuity in Lieu of

Medical Benefits Increase

<u>Background</u>: The negotiated agreements with Service Employees International Union (SEIU), Local 1021 provide for a salary schedule adjustment of four (4) percent and for an increase of the Districts contribution to Tax Sheltered Annuity (TSA) in Lieu of Medical Benefits to \$400 per month. Both of these increases are effective on July 1, 2016.

<u>Fiscal Implications</u>: This action will result in an ongoing four (4) percent increase in the salaries of Classified and Management employees, and an increase in the monthly benefit to Classified and Management employees that qualify for the TSA in Lieu of Medical Benefits to \$400.

Acceleration Project

<u>Background</u>: For the last several years, Chabot College English Instructor Katie Hern has been reassigned from a portion of her faculty duties to serve as Director of the California Acceleration Project (CAP). CAP is a professional development network that supports the state's 113 community colleges to transform English and math remediation to increase student completion and equity. The project has been recognized with the 2015 Mertes Award for Excellence in Research by the Association of California Community College Administrators and an award from the Campaign for College Opportunity, which recently sent a letter of appreciation about CAP to the Board and Chancellor.

CAP is funded through a combination of private grants and state funding, with public funding administered by Los Angeles Community College District (3CSN). The MOU extension covers a portion of Dr. Hern's faculty reassignment for 2015-16. Unfortunately, the paperwork was severely delayed at the Los Angeles Community College District and not received by CLPCCD until mid-January, 2016. Approval of this extension is required for Chabot College to invoice LACCD for the \$39,062 owed for the current year.

Recommended Action: That the Board of Trustees approves the proposed Memorandum of Understanding (MOU) – Los Angeles Community College District, for the reassignment of English Instructor Katie Hern to serve as Director of the California Acceleration Project. Regional Occupation Program (TVROP) and Chabot-Las Positas Community

College District, Las Positas College

<u>Background</u>: Through its Tri-Valley Educational Collaboration (TEC) partnership, Las Positas College (LPC) and the Tri-Valley Regional Occupation Program (TVROP) planned and established a Middle College at LPC for the 2015-16 academic year.

Middle College provides the opportunity for high school students in grades 11 and 12 (35 maximum students in each cohort) to complete high school graduation requirements while dually enrolled in college-level courses. Middle college also prepares students for transfer and high skill careers; engages students in rigorous college preparatory curriculum; improves high school graduation rates; and removes barriers to post-secondary degree attainments such as costs, curriculum alignment, and uncoordinated support services. Students are recruited from Tri-Valley High Schools that include Dublin Unified School District, Pleasanton Unified School District, and Livermore Unified School District.

The initial Memorandum of Understanding for the period of December 9, 2014 through June 30, 2016, was approved by the Board on December 9, 2014, Agenda Item 3.6.

The proposed Memorandum of Understanding Renewal is to continue through June 30, 2018, for a period of two (2) year terms.

<u>Background</u>: California's economy depends upon having a good supply of mathematics and science graduates for the State's science and technology jobs. In order to increase future student interest and engagement in science, technology, engineering and math (STEM) fields, it is critical that we as an educational institution help to prepare and foster future teachers in science and math to foster the pipeline. Therefore, Chabot College would like to collaborate with CSUEB to identify and provide students who are interested in teaching, specifically math and science, an opportunity to participate in a pre-teaching cohort that provides pre-professional development and financial support for field experience opportunities in local K-12 classrooms.

The Board of Trustees has previously approved Memorandums of Understanding for the Affiliate Scholar Program with CSUEB on April 21, 2015 under item 4.3, February 17, 2015 under item 4.2, September 17, 2013 under item 4.4, and November 15, 2011 under item 4.4.

The proposed Memorandum of Understanding (MOU) Renewal is to extend the period an additional year from April 22, 2015 through August 30, 2019 to July 1, 2015 through August 30, 2020, and increase the annual amount hereafter from \$8,000 to \$12,000, effective July 1, 2015.

Approval of Memorandum of Understanding (MOU) - Kaplan Test Prep, a

Division of Kaplan, Inc. and Chabot-Las Positas Community College District,

Chabot College Nursing Program

<u>Background</u>: The purpose of this agreement is to facilitate the student learning outcome testing of the nursing students throughout the two year nursing program. Testing has been reviewed and approved by the California State Chancellor's office for nursing programs in preparation of students for the licensing exam (NCLEX). The testing reflects similar ongoing testing with Assessment Technology (ATI) used by the nursing program since 2003. The national test results comparisons in each of the required areas, Critical Thinking, Fundamentals, Pediatrics, Obstetrics, Advanced Medical Surgical and Leadership, are part of our accreditation requirements for the Board of Registered Nursing (BRN).

Total Cost of the testing will continue to be paid directly by the student to Kaplan on a semester to semester basis of \$135 with a maximum of \$540. This will include the NCLEX four day preparation class after graduation. The Chabot Nursing Program has been purchasing this class for nursing program graduates since 2013 through our Chancellor Retention Grant. The course will now be included in the testing package. The Chabot Nursing Program graduates are currently scoring 96-100 percent NCLEX first time pass rate over the last ten years. The average pass rate in California nursing schools is 84 percent.

In this MOU, Kaplan Testing Prep agrees to designate Chabot-Las Positas Community College District (including its employees and agents) as an "other school official" under FERPA and/or the California Education Code, who has a "legitimate educational interest" in using and accessing such Educational Records.

Approval of Memorandum of Understanding (MOU) – City of Hayward

(COH) in Support of the East Bay Mathematics and Science Teacher

Initiative, Chabot College

Background: California's economy depends upon having a good supply of mathematics and science graduates for the State's science and technology jobs. In order to increase future student interest and engagement in science, technology, engineering and math (STEM) fields, it is critical that we as an educational institution help to prepare and foster future teachers in science and math to foster the pipeline. Chabot is a primary partner in the California State University, East Bay Mathematics and Science Teacher Initiative and is entering into this agreement with the City of Hayward (COH) to carry out the Initiative-related out-of-school time and student transitional support activities on behalf of Chabot.

COH will recruit and train students from Chabot's math, sciences, and engineering tutor/student population to act as tutors in the Hayward Public Library's After-School Homework Support Centers at local middle school and high school sites. Tutors will support students in their math and science subjects between August 2015 and June 2016.

The MOU is for the period of August 1, 2015 – June 30, 2016 and Chabot will compensate COH in the amount of \$11,500. The invoice is to be dated no earlier March 1, 2016.

Recommended Action: That the Board of Trustees approves the proposed Memorandum of Understanding (MOU) with the City of Hayward (COH) in the amount of \$11,500 for the period of July 1, 2015 – June 30, 2016. It is further recommended that the Board authorize the Vice Chancellor, Business Services, to execute the MOU on behalf of the District.

Subject: Approval of Award of RFP No. A-16, District-Wide, Annual Elevator

Maintenance Services

<u>Background</u>: The invitation for bid was solicited to eight (8) potential participants in accordance with state public bidding requirements. On January 11, 2016 and January 12, 2016, two non-mandatory bid walks were held and attended by one (1) interested party. The bid opening was held at the District Office on February 11, 2016 resulting in the following proposal amount:

<u>Bidder</u> <u>City</u> <u>Five (5) Year Total Amount</u> ThyssenKrupp Elevator Corporation San Leandro \$ 205,654.92

An evaluation of the bid submitted deemed that ThyssenKrupp Elevator Corporation as the lowest responsible and responsive bidder. The five (5) year annual maintenance cost includes a 30-day termination clause and a 3% increase. An annual five (5) year load test of \$1,500.00 will be separate from the annual maintenance services contract.

<u>Recommended Action:</u> That the Board of Trustees approves the award of RFP No. A-16, District-Wide, Annual Elevator Maintenance Services to ThyssenKrupp Elevator Corporation of San Leandro, CA in the amount of \$205,654.92. Approval of Contract Modification to the Existing Design/Build Services

Agreement with Lionakis for New Academic Classroom Building 100, Las

Positas College

<u>Background</u>: On May 20, 2014 the Board of Trustees approved the contract with Lionakis to provide bridging architect services for the New Academic Classroom Building 100 at Las Positas College. The agreement provided for optional design services for swing space and renovations of existing space in order to facilitate the relocation of programs currently located in Buildings 100, 200 and 300 which will be removed prior to the construction of the New Academic Building. Modification One provided services to locate six portable classrooms and renovate Building 700 to mitigate the secondary effects of the project. Modification Two provided for additional paths to the portable classrooms project. This additional service provides for added construction meetings and design responses to unforeseen conditions.

Approval of First Amendment to Standard Contract between County of Solano

and Chabot-Las Positas Community College District, Economic Development

<u>Background:</u> Solano County's Health and Social Services Department contracted with Chabot-Las Positas Community College District's Economic Development Department to provide training to group home providers and foster family agencies serving Solano County for the 2015-16 fiscal year. The County has made some revisions to that contract and has issued an amendment reflecting those changes.

No changes have been made to the contract amount (to remain at \$752,055). The amendment includes corrected language in the Exhibit B, which addresses payment provisions. The new language clarifies the role of both parties, specifically removing any reference to Chabot-Las Positas Community College District serving as anything other than a vendor of services.

The Board approved the original County of Solano Contract No. H&SS CWS 00591-16, on June 16, 2015, Board item 7.6.

Approval of Replacement Appointment to Livermore Successor Agency

Oversight Board

<u>Background</u>: In 2012, the Supreme Court abolished Redevelopment Agencies (RDAs). Successor agencies were established to pay the ongoing obligations of the former RDAs.
