Background: The purpose of this College and Career Access Pathways (CCAP) Partnership Agreement is to provide high school students in Leadership Public Schools an opportunity to earn early college credit at Chabot College while enrolled in high school. The intent is to offer provisions of AB 288 and AB 30 (Ed Code 76004) for high school students "who may not already be college bound or who are underrepresented in higher education". The goals are: a.) to develop seamless pathways from high school to community college for career technical education or preparation for transfer b.) improve high school graduation rates c.) assist high school pupils to achieve college and career readiness d.) to serve "underachieving students", those from groups underrepresented in postsecondary education, those who are seeking advanced studies while in high school, and those seeking a career technical education credential or certificate.

These students who earn college credit are more likely to earn high school diplomas, to enroll in community college and four-year colleges, to attend post-secondary education on a full-time basis, and to complete degrees in those institutions than students without these experiences.

(CAPE), Inc. and Chabot-Las Positas Community College District, Chabot

College

<u>Background</u>: CAPE, Inc. (Community Association for Preschool Education) advocates and provides for low-income children, delivering comprehensive services to their families. The Chabot College Children's Center will provide educational services for up to 41 Head Start eligible children (based on enrollment with 30 days of open slots, and HS qualified teaching staff). Children will receive six or more hours of childcare per day, for at least 48 weeks per year, or a total of at least 1525 hours per year, with the exception of during COVID-19 related distance learning service provision. CAPE, Inc. will pay a fee of \$600.00 per month per child from September 1, 2020 thru August 31, 2021, with the exception of July 2021 due to the center closure.

The continuation of this partnership agreement is contingent upon continued funding for CAPE to operate a Head Start Program, and renewable on a yearly basis (for 5 years).

Acceptance of Grant Agreement from Community Initiatives - Immigrants Rising

California Campus Catalyst Fund for Chabot-Las Positas Community College

District – Chabot College

<u>Background</u>: Chabot College has been awarded a grant to expand support for undocumented students and their families. The Catalyst Fund provides an opportunity for campus leaders to develop creative strategies to respond to the needs of large numbers of undocumented students and their families in the California Community Colleges, California State University, and University of California systems.

Specifically at Chabot, funds support expansion of the Dream Resource Center to: support for AB540 and Residency Reclassification Specialist to assist undocumented students and review AB 540 and residency reclassifications petitions; develop Non Credit Course Sequence curriculum for coursework for undocumented students; and develop and implement a virtual outreach strategy to engage with K-12 educators and others in the greater East Bay community, particularly areas with higher numbers of undocumented students who attend or will attend Chabot College.

Funding will be in the amount of \$111,000 for the period of August 3, 2020 through June 30, 2021, with an effective date of August 3, 2019. This is the third and final year. The award was subject to annual renewals contingent upon fulfillment of agreed upon grant objectives.

Recommended Action: That the Board of Trustees accept the Grant Agreement, in the amount of \$111,000 for the period of August 3, 2020 through June 30, 2021. It is further recommended that the Board authorize the Chancellor to execute the agreement on behalf of the District.

Acceptance of Memorandum of Understanding between the City of Hayward (COH) and the Chabot-Las Positas Community College District – Chabot College

- for Emergency Food Distribution

Background: Since April 30, 2020, the City and Chabot College have partnered with the Hayward Area Reaction District (HARD) and Alameda County Community Food Bank (ACCFB) to host a weekly Drive-thru/No Contact Food Distribution site to support community members during the COVID-19 pandemic and resulting economic contraction.

Beginning August 6, 2020, the City needed to secure a new food distribution site. At this time, the College agreed to allow certain areas its campus to be temporarily used for a pilot food distribution effort. Recognizing the mutual benefit of continuing the food distribution while the pandemic continues to impact the community and the City's Emergency Operations Center continues to be activated, the District has agreed to continue to partner with the City to operate the food distribution and certain areas on the College campus to be used once a week for this purpose.

This agreement will remain active during the period of August 6, 2020 through June 30, 2021 and will terminate if the City's Emergency Operations Center deactivates sooner.

Recommended Action: That the Board of Trustees accept the Agreement for the period of August 6, 2020 through June 30, 2021. It is further recommended that the Board authorize the Chancellor to execute the agreement on behalf of the District.

AUTHORIZATION NEEDED TO TAKE ANY AND ALL NECESSARY ACTIONS TO PREPARE AND RESPOND EFFECTIVELY TO THE NOVEL CORONAVIRUS (COVID-19) DECLARING EMERGENCY CONDITIONS EXIST AT LOCATIONS WITHIN THE CHABOT-LAS POSITAS COMMUNITY COLLEGE DISTRICT

WHEREAS, on March 4, 2020 the Governor of California issued a Proclamation of a State of Emergency, on March 10, 2020 Alameda County Board of Supervisors approved a resolution declaring a Local Health Emergency, and on March 13, 2020 the President of the United States declared a National Emergency due to the outbreak and spread of a novel coronavirus (COVID-19); and

WHEREAS, guidance provided to institutions of higher education throughout California and the United States considers the temporary transition of courses, instruction, and other operations to an online or telecommuting environment to be an effective measure against the threat of COVID-19; and, in accordance with such guidance, various institutions of higher education, including community college districts within California, have or are planning to temporarily transition courses, instruction, and other operations to an online or telecommuting environment; and

WHEREAS, strict compliance with various statutes and regulations would prevent, hinder, or delay appropriate actions to prevent and mitigate the effects of COVID-19; and

WHEREAS, it is imperative to prepare for and implement measures to respond to the spread of COVID-19; and

WHEREAS, it is imperative to have the tools to ensure the health and safety of students, employees, and families in our campus communities; and

WHEREAS, it is imperative to have the tools to protect student learning continues if student educational needs are to be conducted from alternate locations or virtual learning environments; and

WHEREAS, the protection of the health, safety and preservation of the lives and property of the people of the State from the effects of natural emergencies such as COVID-19 which may result in conditions of disaster or in extreme peril to life, property, and resources is of paramount State importance requiring the responsible efforts of public and private agencies and individual citizens, and all public employees required to serve as disaster service workers subject to such disaster service activities as may be assigned to them by their superiors or by law under Government Code 3100; and

WHEREAS, Chabot-Las Positas Community College District Emergency Operations Plan empowers the Chancellor authority to proclaim an emergency declaration; and

WHEREAS, California Government Code Section 8630 requires the governing body to review the declaration at least once every 60 days until the governing board terminates the local emergency; and

WHEREAS, Section 1102 of the Public Contract Code defines "emergency" to mean a "sudden, unexpected occurrence that poses a clear and imminent danger, requiring immediate action to prevent or mitigate the loss or impairment of life, health, property, or essential public services," and 21060.3 of the Public Resources Code and California Environmental Quality Act Guidelines 14 CCR section 15269(c) defines "emergency" to mean "a sudden, unexpected occurrence, involving a clear and imminent danger, demanding immediate action to prevent or mitigate loss of, or damage to, life, health, property, or essential public services. 'Emergency' includes such occurrences as fire, flood, earthquake, or other soil or geological movements, as well as such occurrences as riot, accident, or sabotage"; and

WHEREAS, under California Public Contract Code section 20654, in an emergency when any repairs, alterations, work, or improvement is necessary to any facility of a community college to permit the continuance of existing community college classes, or to avoid danger to life or property, the Board may, by unanimous vote, with the approval of the county superintendent of schools, do the following: make a contract in writing or otherwise on behalf the District for the performance of labor and furnishing of materials or supplies for the purpose without advertising for or inviting bids; and, notwithstanding California Public Contract Code section 20655.

NOW, THEREFORE BE IT RESOLVED, that the Board of Trustees of the Chabot-Las Positas Community College District:

- 1. Determines that the circumstances described in the Resolution herein constitute an emergency condition; and
- 2. Authorizes the Chancellor and/or their designee to take any and all actions necessary to ensure the continuation of public education, the health and safety of the students and staff, including, but not limited to: the relocation of students and staff, provision of alternative educational program options, including, without limitation, temporarily transitioning courses, instruction and other operations to an online or telecommuting environment and mode of operation, provision of leave of absence, pursuant to Education Code section 87765 and 88199, to employees due to quarantine or recently returning from State Department Level 3 countries or those who are sick from COVID-19 or illnesses with similar symptoms (e.g. cough, fever, shortness of breath), directing faculty and staff to serve as disaster service workers pursuant to Government Code 3100, and/or to make alterations, repairs or improvements to school property; and
- 3. Determines that the District may enter into any and all contracts necessary, subject to the requirements set forth in California Public Contract Code section 20654, without advertising or inviting bids, and for any dollar amount necessary to respond to the emergency conditions at the District Sites, including, but not limited to: the relocation of students and staff; continued instruction of students; maintenance of supplies, instructional materials, operational support supplies, equipment in support of virtual learning, and provision of additional personnel; and to secure bio-hazard prevention services and supplies; and
- 4. This Resolution shall remain in effect until rescinded by majority vote of the Governing Board

<u>Background:</u> Proposition 15 is endorsed by the Community College League of California, and soon to be endorsed this September 2020 by the California Community Colleges Board of Governors, Proposition 15 is a ballot measure on the November 2020 ballot that seeks to raise needed revenue to invest in schools and vital services for communities across the state. Proposition 15, also known as the Schools & Communities First Initiative, will be a key component to the state's recovery and reinvestment, delivering nearly \$500 million each year to California's community colleges.

Proposition 15 will go a long way in alleviating the serious budget shortfalls caused by the pandemic and allow them greater possibilities to serve their communities. As the largest system of higher education in the state, California's community colleges serve over two million students—training and educating today's workforce for jobs that lead to gainful employment and upward economic mobility.

The Schools & Communities First Act, which recently qualified for the November ballot after submitting a record 1.7 million signatures, will reclaim \$12 billion every year to support essential workers, critical local services, community colleges and K-12 schools by closing corporate property tax loopholes while protecting homeowners and renters, small businesses, and agriculture. Additionally, the initiative provides substantial tax relief for small businesses by cutting the business personal property tax.

Estimated revenue for CLPCCD generated from the Schools & Communities First Act is approximately \$7.9 million. (Source: These estimates were developed by the California Teachers Association using current allocation formulas, based on the aggregate revenue projections published by the <u>USC Program for Environmental & Regional Equity</u>).

CHABOT- LAS POSITAS COMMUNITY COLLEGE DISTRICT RESOLUTION IN SUPPORT OF PROPOSITION 15, THE CALIFORNIA SCHOOLS AND LOCAL COMMUNITIES FUNDING ACT OF 2020 (ALSO KNOWN AS THE CALIFORNIA TAX ON COMMERICAL INDUSTRIAL PROPERTIES FOR EDUCATION AND LOCAL GOVERNMENT FUNDING INITIATIVE 2020)

WHEREAS, for four decades, since the passage of Proposition 13 in 1978, school and community college districts in California have experienced underinvestment and devastating cuts causing California's school funding to fall behind and resulting in fewer services and resources for students;

WHEREAS, while the intent of Proposition 13 is to help homeowners, a loophole in the system permits major commercial and industrial properties to avoid regular reassessment, resulting in an inequitable tax system;

WHEREAS, the California Schools and Local Communities Funding Act does not affect property taxes for homeowners or renters because the initiative exempts all residential property;

WHEREAS, loopholes in California's property tax system allows a fraction of major commercial and industrial properties to avoid regular reassessment and use schemes to hide change in ownership, providing a windfall at the expense of vital school funding;

WHEREAS, the share of the property tax burden has shifted away from commercial property and toward residential property throughout the state;

WHEREAS, California schools are falling behind and state funding per-student support has declined from the top 10 in the nation to the bottom quarter;

WHEREAS, school funding in California is less than the national average, while California's cost of living is among the highest in the nation;

WHEREAS, public schools in California face challenges in providing an equitable and fair education for a student population with vast differences in language, income, parental education level, and other social, educational, and economic factors;

WHEREAS, research has proven that investments in students raises achievement levels, lowers poverty, and increases the productivity of the workforce;

WHEREAS, estimates by academic researchers at the University of Southern California (USC) estimate that the California Schools and Local Communities Funding Act reclaims \$12 billion in property tax revenue every year to ensure that our schools and communities have the resources to educate and support our students;

WHEREAS, USC research shows that a majority of commercial property owners already are assessed at close to market value, making the current system inequitable among businesses, benefitting a relatively small number of properties owned by the largest corporations and wealthy owners who have held land for a long period of time;

WHEREAS, the Schools and Local Communities Funding Act has qualified for the November 2020 ballot;

WHEREAS, the measure invests about \$4.5 billion annually for school and community college districts, over and above Proposition 98 funding;

WHEREAS, the Schools and Local Communities Funding Act will also provide billions in funding annually for cities, counties, and special districts for affordable housing, parks, libraries, health and human services, libraries, and public infrastructure;

WHEREAS, the measure levels the playing field for businesses that already pay their fair share in our communities and exempts all small business owners whose property is worth \$3 million or less;

WHEREAS, the Schools and Local Communities Funding Act will help alleviate the serious budget shortfalls caused by the economic crisis precipitated by the COVID-19 global pandemic and allow community colleges greater options to serve their communities;

WHEREAS, as the largest system of higher education in the state, California's community colleges serve over two million students—training and educating today's workforce for jobs that lead to gainful employment and upward economic mobility;

NOW, THEREFORE, BE IT RESOLVED that the Chabot-Las Positas Community College District Board of Trustees endorses "The California Schools and Local Communities Funding Act of 2020" ballot measure in November 2020 general election.
