CAPE, Inc. (Community Association for Preschool Education) advocates and provides for low-income children, delivering comprehensive services to their families. The Chabot College Children's Center will provide educational services for up to 20 Head Start eligible children (based on enrollment with 30 days of open slots, and HS qualified teaching staff). Children will receive 6.5 or more hours of childcare per day, for at least 48 weeks per year, or a total of at least 1525 hours per year at \$600.00 per month per child. The agreement duration is from September 1, 2023 through August 31, 2024, with the exception of July 2024 due to the campus center closure. The continuation of this partnership agreement is contingent upon continued funding for CAPE to operate a Head Start Program, and renewable on a yearly basis, up to five years.

BACKGROUND INFORMATION -

Chabot College applied for and was awarded the CCAMPIS grant from the US Department of Education. This builds upon and enhances the sunsetting CCAMPIS grant (P335A190370), previously approved as board item 4.1 on December 23, 2019 and augmented October 18, 2022 as board item 4.8.

Funding supports the Chabot College Children's Center (CCCC), a laboratory school at Chabot College working in tandem with the Early Childhood Development (ECD) Department. The project aims to address the need for subsidized infant/toddler childcare and supports prioritizing low-income student parents. Activities include: 1) expanding CCCC capacity by opening one additional infant toddler classroom; 2) providing Parent Night Workshops and academic counseling; 3) strengthening cross-agency and community engagement; 4) providing professional development; and 5) achieving National Association for the Education of Young Children (NAEYC) accreditation.

Funding for this project is in the amount of \$2,000,000 for the period of October 1, 2023 through September 30, 2027.

Chabot-Las Positas Community College District, Las Positas College has received a National Nuclear Security Administration (NNSA) grant award, Award number DE- NA0004160. The long-term goal and relevance of the project is to build a responsive, workforce education system that provides the following outcomes: 1.) a continuous flow of diverse, trade/technician-skilled workers to Lawrence Livermore National Lab (LLNL), part of the Nuclear Security Enterprise; and 2.) enhancement of the incumbent LLNL technician workforce. REAP is focused on two of the three major pathways to achieve Nuclear Security Enterprise mission priorities: capacity building/pipeline development; and recruitment and marketing, retention, and development of a world-class and diverse workforce. The grant provides \$500,000 to Chabot-Las Positas Community College District, Las Positas College over the course of three years.

The agreement will be for the period October 1, 2023, through September 30, 2026, but no activities under the grant will be undertaken prior to Board approval of the agreement.
