BACKGROUND INFORMATION -

This agenda item relates to a proposed faculty-led study abroad learning experience in Seville, Spain. Las Positas College's Dr. Elizabeth Wing Brooks and Dr. Catherine Eagan propose to offer two hybrid courses, HUMN 11 Arts - Culture and the Arts I: Ancient World to Renaissance and ENG 45 Studies in Fiction, in early summer 2026. The first three weeks of the course, beginning June 8, 2026, will be spent in Seville, Spain to learn in person, on site, in an immersive setting. The courses will be completed three weeks after the trip has concluded. In Spain, students will mix classroom time with time visiting sites in Seville and nearby areas of Spain to provide for experiential learning. They will also do homework on their own in their residences and in groups during evening activities.

The selected provider for this trip is AIFS, a provider with decades of experience running credit-bearing study abroad trips for community college consortia and individual faculty. The major terms of the attached agreement are that AIFS provides pre-departure support services, health and safety support, airport transfers, home stay accommodations with breakfast and evening meals, a welcome meal and farewell meal with flamenco show, in-country student support, academic support, and various cultural activities and excursions, all outlined on the attached proposed itinerary. Faculty support includes accommodation in a self-catered studio apartment and "full participation on all activities and excursions scheduled on the itinerary, on the same basis as the students, including travel pass, group meals, transfers, entrances, sightseeing tours, etc." Airfare is not included.

The Hayward Public Library is launching a Community HUB in partnership with Hayward Promise Neighborhoods (HPN). Community partners are being invited to share their resources directly with the community through this hub. Partners will have access to a dedicated, secure, and fully stocked office space to provide individual/confidential support to clients/residents/students. There will be a closet with basic needs resources for residents accessing and/or being referred to the resources offered through this space. Chabot College will partner to provide information and resources regarding adult education programs.

More specifically, Chabot College staff will provide information and support around applying and enrolling into our non-credit ESL courses, and Adult Career Technical Education and Adult Dual Enrollment programs. Staff will also assist with financial aid applications (FAFSA, CADAA, and Cal Kids) and provide information on the Chabot College Promise program.

No additional funding is needed as the Chabot College HPN team will work with fellow outreach specialists to staff the hub during the allotted time slot on the first and third Mondays of the month from 2-5PM.

BACKGROUND INFORMATION -

The purpose of this College and Career Access Pathways (CCAP) Partnership Agreement is to provide high school students expanded opportunities to earn early college credit. The intent is to offer provisions of AB 288 and AB 30 (Ed Code 76004) for high school students “who may not already be college bound or who are underrepresented in higher education.” One unique aspect of this TVROP CCAP Agreement is that students from all three local school districts are able to attend any approved CCAP course.

The goals are:

- To develop seamless pathways from high school to community college for career technical education or preparation for transfer,
- To improve high school graduation rates,
- To assist high school pupils to achieve college and career readiness,
- And, to serve “underachieving students,” those from groups underrepresented in postsecondary education, those who are seeking advanced studies while in high school, and those seeking a career technical education credential or certificate.

The students who earn early college credit are more likely to earn high school diplomas, to enroll in community college and four-year universities, to attend post-secondary education on a full-time basis, and to complete degrees in those institutions, than are those students without these experiences.

The term of this CCAP Agreement shall begin on June 18, 2025 and ends when terminated in accordance with Section 19 of this CCAP Agreement. The Community College League of California (League) is a nonprofit public benefit corporation whose voluntary membership consists of the state's 72 public community college districts. The League supports locally-elected trustees and community college CEOs in serving their students and communities by advocating on their behalf at the state and federal levels, providing continued professional development, and delivering services that use economies of scale to minimize cost. The League has a joint project with the Chief Council of Librarians to provide a Community College Library Consortium. The Chief Council of Librarians charges an annual fee for libraries to be a part of the consortium.

The open purchase order form is for the annual subscription to online library materials and online databases that provide access to magazines and journals, eBooks, streaming media, and other research content. The open purchase amount is \$150,000 for fiscal year 25-26.

BACKGROUND INFORMATION -

The Education Protection Account (EPA) was established as a result of passage of The Schools and Local Public Safety Act (the Act) of 2012 (Proposition 30) in November 2012. A community college district has the sole authority to determine how the monies received from the Education Protection Account are spent provided that the Board of Trustees approves the spending determination in an open session of a public meeting. The district shall not use any of the funds from the Education Protection Account for salaries or benefits of administrators or any other administrative costs. In addition, the Act requires that a) the district publish on its Internet web site an accounting of how much money was received from the EPA and how that money was spent, and b) the annual independent financial and compliance audit shall verify whether the funds provided from the Education Protection Account have been properly disbursed and expended as required.

The District has identified \$78,928,737 of eligible expenditures through May 2025 to be expended against an estimated annual EPA allocation of \$15,958,993. This puts the District fully in compliance with the Act.

BACKGROUND INFORMATION -

On May 20, 2025 the 2025 Facilities Master Plan Updates (FMP) were presented to the Board of the Chabot-Las Positas Community College District. The FMPs in detail focus on the two campuses and District Office for their current and future functions over the next 10 to 15 years to meet the District Educational Master Plan, District Strategic Plan and Mission Statement.

The Facilities Master Plan update for each college is organized into six sections: 1) Introduction to the college, 2) Introduction to the Facilities Master Plan Update (FMP Update), 3) Linking the Educational Master Plan to the FMP Update, 4) College's Existing Conditions, 5) College's Vision, and 6) Appendices. Each document provides shared governance processes, context and overview of the facility, connection to the strategic plan and educational master plans, campus design goals, campus zoning, major project program of work definitions, and an impact of implementation on timing of the work to be completed. Technical appendices are provided identifying enrollment trends, glossary of terms and acknowledgements.

For each of the college campuses, the FMP documents an overall approach to physical development. Each plan recognizes the character, history and culture of the respective campus. At Chabot College, the FMP moves development to respect the current campus zoning, enhance access and identity of the campus, and balancing facilities, outdoor amenities and improvements in learning environments and technology. At Las Positas College, the FMP moves development to completion of the campus organization that engages both topography and distance to established building sites and place-making. The resulting FMP provides a welcoming, completed campus which fully utilizes the available space and welcomes the community to campus and the vistas of the Livermore hills, while maintaining the existing program groupings and multidisciplinary building flexibility.

The FMP's provide a menu for the District and each College to use in configuring projects, supporting campus fund requests, applying for State funding and expenditure of the Measure A Bond funds. The design of each project site and facility will take place as projects are funded and detailed programming occurs. The FMPs remain flexible and living documents in response to resource allocations, unanticipated changes and phasing capabilities, and will support future educational master planning efforts.

Along with research and data, the FMPs inform the annual update of the Five-Year Capital Plan. Working in tandem with the Education Master Plans, the Five-Year Capital Plan utilizes the FMPs to align facilities for educational programs, update the infrastructure to support educational facilities and effectiveness of facilities, support student activities on campus, improve exterior environment to support education, retain students on-site and engage the community and balance capacity load ratios.

Through the shared governance process, the planning approach was highly participatory, the administration, senates, faculty, staff and students attended presentations in multiple cycles of brainstorming, master plan programming, development of phasing approaches and drafting facilities master plan documents.

BACKGROUND INFORMATION -

Pursuant to Article XIII-B of the Constitution and Chapter 1205, Statutes of 1980, all community college districts are required to compute an annual appropriations limit.

Government Code Section 7908(c) requires each community college district to report to the Chancellor of the California Community Colleges at least annually its appropriation limit, appropriations subject to limit, the amount of state aid appropriations and subventions included with the proceeds of taxes of the district, and amounts excluded from the appropriations subject to limit.

Recent legislation (Assembly Bill 130) automatically transfers any community college's excess appropriation limits to the state of California. Beginning in Fiscal Year 2025–26, community colleges with excess limit must adopt a new appropriations limit that equals their proceeds of taxes, thereby transferring any available limit to the State of California.
