The purpose of this amendment to the previously approved Memorandum of Understanding (MOU) is to authorize the Alameda County Office of Education (ACOE) and the Chabot-Las Positas Community College District, Las Positas College, to expand and leverage funds from the California Department of Social Services (DSS) Quality Counts California Workforce Pathways Grant.

This amendment will enhance support in the areas of Workforce Higher Education and Workforce Advising, as specified by ACOE and DSS. The primary goal is to promote the increased learning and healthy development of California's young children by:

- 1. expanding the number of qualified early learning and care professionals; and
- 2. advancing the educational credentials, knowledge, and competencies of the existing early learning and care workforce across the State.

The total amount of the amended MOU is \$17,620. The original MOU was approved by the Board as item 4.3 on May 20, 2025. This agreement shall become effective upon execution by both parties and shall remain in effect through June 30, 2026.

BACKGROUND INFORMATION -

The Chabot-Las Positas Community College District, Las Positas College received a program renewal for the Child Development Training Consortium (CDTC) 2025 -2026 Instructional Agreement No 25-26-2620 with the Yosemite Community College District. The initial agreement, approved by the Board of Trustees on October 15, 2024 as item 4.3, allowed the College to generate up to 600 units of college credit by enrolling students in courses required by the California Commission on Teacher Credentialing to obtain a new or renew a currently held Child Development Permit. As these courses do not generate state apportionment, the agreement provides the College with \$35 per enrolled unit of coursework, not to exceed a total of \$27,600.

This MOU shall become effective upon the date of execution by both the parties and shall continue until June 30, 2026.

BACKGROUND INFORMATION -

On December 12, 2023, the Chabot-Las Positas Community College District (CLPCCD) Board of Trustees approved the California Regional K-16 Education Collaboratives Grants Program under Board item 4.8. This \$18,130,000 K-16 Implementation Grant award recognized CLPCCD as the lead for the Bay Area K-16 Collaborative, a regional network focused on pathways to degrees and post-Baccalaureate careers in Education, Engineering/Computing, and Healthcare/Biotechnology.

CLPCCD is the lead for regional networks of educators, employers, and community partners to achieve the grant objectives and deliverables across five counties in the Bay Area. Funding is supporting key priorities of the CLPCCD, Chabot College, and Las Positas College. The Collaborative, led by CLPCCD, is committed to removing barriers to degree completion, accelerating transfer success, increasing equitable participation in early college credit, and expanding work-based learning for historically underrepresented students across the Bay region.

This amendment provides a no-cost extension of the grant implementation period by two years, extending the end date to June 30, 2028. In alignment with the new deadline in AB121, the Office of Public School Construction (OPSC) and CLPCCD agree to modify the remaining reporting requirements of the original Grant Agreement. No additional funding has been allocated to CLPCCD for the Bay Area K-16 Collaborative.

BACKGROUND INFORMATION -

Chabot College was awarded the National Science Foundation 24-551 Hispanic-Serving Institutions: Enriching Learning, Programs, and Student Experiences (NSF ELPSE) Grant (Award number 2524513).

Funding supports purchasing a new Nuclear Magnetic Resonance (NMR) spectrometer to replace an outdated version. This aims to increase opportunities for Chabot STEM students in Organic Chemistry courses to develop basic NMR spectrometer lab skills, and subsequently, build confidence to utilize the instrumentation in future baccalaureate and career pursuits.

The California Community Colleges Chancellor's Office entered into an interagency agreement with the California Department of Health Care Access and Information (HCAI) to fund the planning and implementation of a statewide Certified Wellness Coach Apprenticeship Program.

Due to our experience with creating the Behavioral Health Specialist apprenticeship program, Chabot–Las Positas Community College District and Chabot College were selected as one of three pilot sites in California for this program. This grant will allow us to grow our current program and work with public social services agencies and county offices of education, and expand into the North/Far North regions of the State. Our existing relationships with county social service agencies through our child welfare training program will enable us to identify employers for the approximately 20 apprentices who will be part of this pilot.

The Grant Agreement between the California Community Colleges Board of Governors and Chabot–Las Positas Community College District covers the period from October 1, 2025, through September 30, 2029, in an amount not to exceed \$697,345 over the four-year term.

The California Community Colleges Chancellor's Office entered into an interagency agreement with the California Department of Health Care Access and Information (HCAI) to fund the planning and implementation of a statewide Certified Wellness Coach Apprenticeship Program. Because of the extensive experience we have with our Behavioral Health Specialist apprenticeship program, the Chabot–Las Positas Community College District was selected to provide technical assistance to three California pilot sites, as well as to develop and disseminate tools that support broader replication of the model.

Tasks included in this grant include facilitating learning communities to support equity in entry, retention, and employment related to behavioral health apprenticeship programs; coordinating the development of tools to identify and disseminate best practices to support a successful apprenticeship program; and identifying and uplifting state systems change to overcome barriers, streamline systems, and increase student impact.

Under this agreement, the California Community Colleges awarded Chabot–Las Positas Community College District a four-year technical assistance provider grant totaling up to \$688,148, for the period from October 1, 2025, through September 30, 2029.
