BACKGROUND INFORMATION -

Chabot-Las Positas Community College District (CLPCCD) received an additional allocation of twenty thousand dollars (\$20,000) through the existing Cooperative Agreement with the Regents of the University of California on behalf of the Puente Project, to support the Puente Program at Las Positas College. The original agreement was approved by the CLPCCD Board of Trustees on September 12, 2023, item 4.6. This allocation reflects an allocation under the current agreement and will be used to directly support students currently enrolled in the Puente program, including those who have previously participated and have not yet transferred.

The mission of the Puente project is to increase the number of educationally underrepresented students who enroll in four-year colleges and universities, earn degrees, and return to the community as leaders and mentors to future generations. The first Puente Project was initiated at Chabot College in 1981. Since that time, the model has been replicated at 74 colleges and 34 high schools throughout the State of California, with the oversight of the Puente Project centralized through the Regents of the University of California. The Puente Project was established in 2012-13 between the University of California and Chabot-Las Positas College, Las Positas College.

The Puente Math and Science Program known as Puente MÁS Program was piloted at LPC in 2022. It allowed the addition of the math component to its current model. The previous model of the Puente program was English, Counseling, and Mentoring. The model now has four components English, Math, Counseling, and Mentoring. The Puente MÁS program is now fully implemented at Las Positas College and it has been since 2023.

Use of Funds: The \$20,000 in funding will be used to:

- Plan special events and activities that increase student engagement and success
- Purchase educational materials that supports student success and retention

Per the terms of the agreement, the funds must be spent by June 30, 2026, and may not be used for salaries, student scholarships, or non-Puente-related activities. Unused funds must be returned to the Puente Project by September 30, 2026.

BACKGROUND INFORMATION -

Chabot College was awarded the U.S. Department of Education TRIO Student Support Services Teacher Prep grant supporting low-income, first-generation, and disabled college students.

Funding supports comprehensive academic supports, proactive counseling/advising, career exploration, financial aid education, individualized transfer supports, and financial literacy services for eligible TRIO SSS Teacher Prep students. These are offered through a variety of strategies: counseling and advising using continuous follow-up; a strong academic focus; connection and support to work placements, service learning, work-based learning, and apprenticeships; career speaker panels; four-year college tours; assistance in transferring to a four-year institution; and group services to maximize student contact with program staff and each other, creating a support network.

Funding for this project is in the amount of \$194,500 annually, with total funding over five years at \$972,500 for the period of September 25, 2025 through September 24, 2030.

Las Positas College and Ambassadors Media Group are proposing to enter a partnership to offer instructional programs in local middle schools and high schools to enhance skills that lead to improved employability, leadership, resiliency, and positive mindset. Upon completion of the program, students will earn an "Emotional Intelligence in the Workplace" certificate of completion.

Las Positas College proposes this Instructional Services Agreement for Noncredit Education programs between Las Positas College and Ambassadors Media Group for up to 78 hours in Noncredit instruction at a rate of \$6.94 per hour. The college will pay a maximum of \$541,320.00 per fiscal year, with the cost being offset by apportionment revenue.
