BACKGROUND INFORMATION -

Vice Chancellor Nicholas will provide a brief presentation on key elements of the Governor's January Budget Proposal for FY 2026-27 and preliminary analysis of potential impact to our district.

Key elements of the Governor's Budget Proposal include:

High Level Takeaways:

- The Governor's budget is revenue strong, but risk aware, driven largely by volatile capital gains.
- Education funding grows on paper, but the state continues to delay Proposition 98 payments as a cash management strategy.
- Community colleges fare better than other segments, but gains rely heavily on one-time funds, not durable base growth.

CCC Core Funding (SCFF):

- SCFF fully funded in 2026-27
- Statutory COLA: 2.41% (lower than prior assumptions)
 - ~\$240.6M ongoing statewide cost
 - Partially supported by a onetime Prop 98 reserve draw (\$44.5M)
- \$408.3M to fully retire outstanding SCFF deferrals

Enrollment Funding:

- State assumes continued enrollment recovery
- Funded growth:
 - 1.0% growth in 2025-26 (\$55.3M)
 - 0.5% growth in 2026-27 (\$31.9M)
- 1.5% total growth assumption is now embedded in the base

Other Investments:

- \$100M onetime flexible block grant
- \$120.7M onetime for deferred maintenance (first new funding in three years)
- \$736.9M in Proposition 2 bond funds for CCC capital projects
- Targeted augmentations:
 - Common Cloud Data Platform
 - Credit for Prior Learning
 - Apprenticeship RSI backfill
 - California Healthy School Food Pathways
 - \$38.1M ongoing to stabilize Calbright College
- \$346.4M offset from increased local property tax revenues (ongoing)

Summary:

- CCC is relatively favored, but primarily through one-time funding.

- Cash timing risk persists due to ongoing Prop 98 deferrals.
- Enrollment performance matters more than ever under SCFF.
- COLA helps, but structural cost growth outpaces revenue growth.

- Kaiser Foundation Hospitals and the Permanente Medical Group, Inc. has the facilities and personnel throughout its Northern California hospitals, medical office buildings and other licensed facilities ("Medical Center(s)") that are able to provide clinical and observational experience to students enrolled in School's educational training programs.
- Chabot-Las Positas Community College District, Las Positas College desires to arrange with Kaiser Permanente clinical and observational experience for School's Students and Kaiser Permanente desires to provide such training experience. This Agreement governs the establishment and operation of clinical and observational programs at Medical Centers. At the sole discretion of each Medical Center, it and the School may make arrangements for such programs, on the terms and conditions set forth herein, in areas of practice supported by School curricula, without limitation. Each area of specialization, (e.g., physical therapy, nursing, or administrative services), in which a program is established is a "Clinical Program." Each Clinical Program is covered by this Agreement and is incorporated herein by this reference.

- The initial term of this Agreement shall commence on the 21st day of January, 2026 and shall continue in effect unless and until terminated by any party in accordance with Section 11.B. This Agreement may be terminated by any party with thirty (30) calendar days prior written notice to the others. Notwithstanding the foregoing, this Agreement may be terminated immediately by Kaiser Permanente in the event the School fails to maintain coverage required by Section 10, and such termination shall be a termination with cause.

The purpose of this MOU is to begin a partnership between Las Positas College and the Alameda County Sheriff's Office (ACSO). This collaboration aims to meet the educational needs of persons who are incarcerated at Santa Rita Jail by making college-level courses accessible, including CSU/US transferable, general education courses, noncredit, and degree/certificate courses.

This MOU further establishes the operational framework for Las Positas College to offer college courses to the students who are incarcerated and housed in Santa Rita Jail, run by the ACSO. Five Keys and Chabot College currently operate all educational programming in the jail and will provide support to ensure a smooth transition through the meeting of the monthly Advisory Board.

The term of this MOU agreement shall be ongoing, beginning on January 21, 2026. This MOU agreement may be revised by mutual written agreement at any time and may be terminated 60 days after receipt of written notice of intent to terminate by either party.

Under this agreement, ERS Medical will perform annual and periodic maintenance, emergency response, corrective repairs, equipment calibration, and documentation of all work completed. Chabot College Nursing Skills Lab will supply replacement parts and retain responsibility for equipment operations, while ERS Medical provides technical support and recommendations. The term of the agreement is one year from the effective

date, with automatic annual renewal unless terminated with 30 days' written notice. This agreement supports the Nursing Program by ensuring that biomedical equipment remains safe, functional, and compliant with regulatory standards required for instructional and clinical training.

The term of this agreement shall begin on November 24, 2025, as requested by Kaplan. This contract meets all Board of Registered Nursing requirements for clinical facilities for the Chabot Nursing Program.

BACKGROUND INFORMATION -

The purpose of this College and Career Access Pathways (CCAP) Partnership Agreement is to provide high school students in the Eden Area ROP an opportunity to earn early college credit at Chabot College while enrolled in high school. The intent is to offer provisions of AB 288 and AB 30 (Ed Code 76004) for high school students "who may not already be college bound or who are underrepresented in higher education".

The goals are:

1. to develop seamless pathways from high school to community college for career technical education or preparation for transfer
2. improve high school graduation rates
3. assist high school pupils to achieve college and career readiness
4. to serve “underachieving students”, those from groups underrepresented in postsecondary education, those who are seeking advanced studies while in high school, and those seeking a career technical education credential or certificate.

These students who earn college credit are more likely to earn high school diplomas, to enroll in community college and four-year colleges, to attend post-secondary education on a full-time basis, and to complete degrees in those institutions than students without these experiences.

This board action is requesting approval of an update to the existing CCAP agreement with a start date of January 2026, which will reflect the new agreement reached on compensation for part-time faculty teaching in our K12 partner districts.

CLPCCD and Eden Area ROP have an existing College and Career Access Pathways (CCAP) agreement, and the agreement was last updated and Board-approved on January 17, 2023, as Board Item 4.5.

This agreement establishes a collaboration between Strategic Energy Innovations (SEI) and Chabot College to implement the Energize Colleges Program, which promotes sustainability education and workforce development through experiential learning. The program provides paid internships for students and supports faculty and staff in integrating energy and sustainability concepts into curriculum. Upon execution; program runs through August 31, 2026.

SEI Acts as Employer of Record for interns. Interns earn \$20/hour for up to 150 hours per intern for the entire program term (20 hours/week max). SEI provides training, payroll, insurance, and program oversight and pays a \$750 stipend to the Site Supervisor. Each project will focus on energy efficiency and sustainability.

Dan Quigley at Chabot College agrees to host up to two interns, provide workspace, supervision, and project-based learning opportunities. The intention is to build upon our Community of Practice where faculty and SEI staff collaborate to integrate sustainability into curriculum.

SEI requests ownership of rights to all curriculum and training materials; Chabot College receives a non-exclusive license for internal use. Accompanying the Service Employees International Union, Local 1021 Memorandum of Understanding (MOU) on the agenda, this resolution authorizes the District to provide a Supplemental Employee Retirement Plan (SERP) to SEIU and Unrepresented (Confidential, Supervisor, and Administrative) employees, effective July 1, 2026 for Group 1 or January 1, 2027 for Group 2.

The SERP provides eligible long-tenured employees with a voluntary retirement incentive equal to 65% of their base annual salary at the time of retirement. In addition to offering a meaningful benefit to employees, the program generates long-term savings for the District, allowing for strategic reinvestment. A SERP is a proactive fiscal tool that supports ongoing stability, enables planned transitions that preserve institutional knowledge, and positions the District to continue investing in core student and community priorities.
