## REPORT OF ACTION TAKEN IN CLOSED SESSION

President Cedillo reported that in Closed Session the Board unanimously accepted the resignation of a probationary academic employee to be effective at the end of the school year. The employee will provide some distance learning services, and otherwise be on paid administrative leave until that time. The motion was made by Mrs. Dvorsky and seconded by Dr. Gin.

### PRESENTATION: ONE-TIME MONIES

Chancellor Cota reported that at the end of last year, \$1 million was allocated to both Colleges and the District for special projects to be spread over a two-year period. She explained that tonight, the presenters will give an update on how that money is being used.

Ms. Pam Luster, Ms. Birgitte Ryslinge and Mr. Jeff Baker presented an update on the Las Positas College One-Time Money Projects, deemed "Innovation for Success" Projects. These projects include:

- International Students Program (to be presented by District staff)
- Entrepreneurial Resource Center
- Grant Writer
- Equity, Access and Success (Campus Change Network)
- Outreach
- Retention Strategies

Ms. Melinda Matsuda and Dr. Ronald Taylor presented an update on the Chabot College One-Time Money Projects, which include:

- Community Outreach and Recruitment
- Student Retention
- Evening and Saturday Program
- Off-Site Course Offerings
- On-Line Initiative

Ms. Carolyn Arnold presented the process Chabot College will use for evaluating the results of the overall projects.

Dr. Lewis questioned the Friday schedule. Dr. Mertes raised the question of the rationale of block scheduling. After a brief discussion, Dr. Cedillo noted the need to get back to the presentation at hand and suggested this issue be brought back at a future Board Meeting for further discussion.

Dr. Joel Kinnamon, Ms. Laura Weaver and Ms. Jennifer Aries presented an update on the District One-Time Money Projects, which include:

- International Student Program
- Marketing and Recruitment
  - o College Website Navigation Redesign Project
  - o Districtwide Market Research Project (CLARUS Corporation)

On behalf of the Board, Dr. Cedillo thanked staff for the wonderful presentation, noting that it is remarkable what has been done with these funds.
