### **REPORT OF ACTION TAKEN IN CLOSED SESSION**

Trustee Mr. Vecchiarelli reported that in Closed Session the Board unanimously approved to renew the contract of the Chancellor, Dr. Jannett N. Jackson, for a three year period, beginning July 1, 2016 through July 31, 2019. The motion was made by Trustee Dr. Cedillo and seconded by Trustee Dr. Gin. Trustees Dvorsky and Gelles were absent.

### **PUBLIC COMMENTS**

Ms. Holly Billington-Ferrer spoke to the Board regarding bringing two programs to Chabot College: 1) Alpha Gamma Sigma Honors Transfer Program; and 2) U.S. Collegiate Archery

Program. She noted that the U.S. Collegiate Archery (USCA) Program would be at no cost to the College; USCA provides the necessary equipment.

Recognition and Medallions were also presented to Staff, Coaches, and Assistants. Chancellor Jackson read the Congressional Record in Recognition of Chabot College Women's Basketball Team presented by the Honorable Eric Swalwell at Chabot College on April 20, 2015. She noted that this Congressional Record will be chronicled in Washington, D.C.

Trustee Mr. Vecchiarelli expressed that he has had many proud days while an employee and Trustee with the Chabot-Las Positas Community College District, and the Chabot College Women's Basketball Team Championship is one of them.

### **GOOD OF THE ORDER**

Chancellor Jackson welcomed the new Director of Maintenance and Operations, Mr. Walter Blevins.

### **PRESENTATION: ACCREDITATION UPDATE**

Chancellor Jackson reported that both Colleges are well into the Accreditation cycle. She reported that the visit by the Accrediting Commission for Community and Junior Colleges (ACCJC) is scheduled for October 5-8, 2015.

#### Chabot College

Dr. Susan Sperling introduced Dr. Stacy Thompson, Vice President, Academic Services and Mr. Jim Matthews, Accreditation Liaison Officer (ALO).

Dr. Stacy Thompson and Mr. Jim Matthews presented a PowerPoint Presentation Update on Accreditation.

Mr. Jim Matthews presented a timeline to Completion as follows:

- December 2014 – Final Committee drafts submitted;
- January-February – Steering Committee worked with chairs to edit drafts;
- March – Early April – Editor worked on draft;
- April – Steering Committee/Chairs review/edit draft;
- April 22 – Draft posted to the community for comments;
- April 30 and May 5 – College Forums;
- May 11 – All College comments due;
- May 21 – Academic Senate approves draft;
- May 27 – College Council approves draft;
- June 16 – Board receives draft for comments (First Reading);
- July 21 – Board approves the Self-Evaluation Report (Second Reading);
- July 31 – College sends the report and all required documents to ACCJC.

Mr. Matthews reviewed the Possible Action (Improvement) Plans as follows:

- Governance: New Governance Structure;
- Strategic Planning and Budgeting (IEPI Initiative);
- Student Learning Outcomes (SLO) Progress;
- Planning: Educational Master Plan 2015;
- Completion Goal Setting;
- Others that have not been vetted as yet.

Presenters reviewed the progress/accomplishments of Recommendations as follows:

Recommendation No. 1 – Student Learning Outcomes:

- Moving all SLO data from eLumin to Curricu-NET;
  - Easier to input data; easier to run reports;
  - Same system used to store curriculum outlines;
  - 95.2% of Programs with PLO's written (157 out of 165 programs).

Recommendation No. 2 – Program Review:

- Program Review process has been assessed and revised by PRBC;
- Based on those results, will convert to Curricu-NET Fall 2015;

Recommendation No. 3 – Library and Learning Support Services:

- Recommendation Concerns Program Review and Assessments
  - All assessments have been completed;
  - Results have been institutionalized within Program Review.

Recommendation No. 4 – Institutional Planning:

- College Strategic Planning has been combined with Program Review and Student Learning Outcomes in the PRBC (Program Review and Budget Council);
- College Budget allocations are made based on the College Strategic Plan Goal;
- College engages IEPI group for Fall 2015;
- District Initiatives: New Planning Committee Structure;
- District Initiatives: District Supported College Educational Master Plan Initiative (District Master Plan) – February 2015 Charrette.

Recommendation No. 5 – College Governance:

- Review is moving forward with Faculty Senate and PRBC Leadership;
- College Committees are reviewing and assessing their bylaws and charges;

It was reported that the College has met its set standards for 1) course success rates; and 2) degrees awarded. However, the College continues to strive to meet its set standards for 1) certificates awarded; and 2) transfers to 4-year colleges.

Las Positas College

Dr. Barry Russell introduced and recognized the hard work of Elena Cole. He reported that the Draft Self-Evaluation has been completed.

Ms. Elena Cole presented a PowerPoint Presentation Update on Accreditation.

Key Sections of the Draft included in the Self-Evaluation include:

- Eligibility Requirements;
- Standards;
- Compliance with Federal Regulations and Commission Policies;
- Response to Recommendations from 2009 Team Visit;
- Actionable Improvement Plans.

The Accreditation Calendar Timeline was reviewed:

- November 4: Self-Study Draft submitted to Steering Committee;
- November-January: Steering Committee review of Self-Study Draft in collaboration with Accreditation Writing Teams;
- January-March: Edit of Self-Study Draft;
- March 4: Town Hall presentation of Self-Study Draft;
- March-April: Draft posted to community for comments.
- April-May: Revision of Self-Study incorporating community feedback;
- May 13: Post second draft for community feedback;
- May 27-28: Academic Senate and College Council approval process;
- June 16: Board receives draft for comments (First Reading);
- July 21: Board approves Self-Study Report (Second Reading);
- July 31: College sends report and documentation to ACCJC.

The Summary of Action Plans was reviewed:

- Support more robust assessment of SLOs at the course level;
- Improve communications through the college web site;
- Develop mechanisms to assess the effectiveness of District Services;
- Add a crime statistics report for Las Positas College's off-campus site, Livermore Valley Charter Preparatory High School, to the Cleary Report.

The Student Learning Outcomes progress was reviewed:

- Courses with SLOs – 98%.
- Courses with On-Going Assessments – 78%;
- Degrees, Certificates with Outcomes – 100%;
- Degrees, Certificates with On-Going Assessments – 92%.



It was reported that the College has met its set standards for 1) course success rates; and 2) transfers to four-year colleges. However, the College continues to strive to meet its set standards for 1) degrees awarded; and 2) certificates awarded.

The progress/accomplishments of Recommendations since the Mid-term Report were reviewed as follows:

Recommendation No. 1:

- Increased capacity for conducting research by hiring a research assistant;
- Conducted additional assessments of college processes;
- Re-evaluated and revised committee structure;
- Created Integrated Planning Committee.

Recommendation No. 2:

- Improved percentages of SLOs written and assessed at the course, program, and institutional levels;
- Negotiated MOU to engage part-time faculty in SLO process;
- Continued to evaluate and refine program review processes.

The accomplishments since October 2014 were reviewed:

- Improved percentages of course SLOs written from 96% to 98%;
- Improved percentages of course SLOs assessed from 59% to 78%;
- Improved percentages of program outcomes written from 76% to 100%;
- Improved percentages of program outcomes assessed from 61% to 92%.

Trustee Dr. Mitzman requested further explanation of the Las Positas College Action Plan to add a crime statistics report for off-campus site, Livermore Valley Charter Preparatory High School, to the Cleary Report. In response, Dr. Russell and Ms. Elena Cole explained that it is a requirement that off-campus sites are included in the Cleary Report. Dr. Russell reported that it is a requirement of the Cleary Act that all K-12 school districts and community colleges include crime statistics on their websites (Public Records Act). Dr. Sperling spoke to the status of this issue at Chabot College, which has the same requirement.

In response to a question raised by Student Trustee Dolorito, Mr. Matthews confirmed that students in all classes are included in the Student Success Rates.

Dr. Thompson noted that she is proud that both Colleges have “moved the needle” in regards to Student Success Rates.

Trustee Dr. Gin recognized all the hard work that has gone into the Accreditation Process, noting that it is a “daunting task.” He congratulated both teams.

**PRESIDENTS OF CHABOT AND LAS POSITAS COLLEGES FACULTY SENATES**

Ms. Laurie Dockter, President, Chabot College Faculty Senate, reported that MiG will present on the Educational Master Plan at the Faculty Senate Meeting scheduled this week.

Dr. Tom Orf, President, Las Positas College Faculty Senate, reported that the Faculty Senate will meet this week. He reported that Chancellor Jackson will present at their next meeting. In addition, the Senate will discuss Accreditation. He reported that the Staff Appreciation Festival will be held Wednesday, April 29. He reported that the Senate elections are occurring, including the selection for Senate President and the Buffington Award.

**PRESIDENTS OF CHABOT AND LAS POSITAS COLLEGES AND DISTRICT CLASSIFIED SENATES**

Mr. Gordon Watt, President, Chabot College Classified Senate, had no report.

Ms. Heidi Ulrech, Las Positas College Classified Senate, reported that Classified Senate elections are occurring, as well as nominations for the Outstanding Classified Employee Award. She also reported that the Flex Day on April 1 was successful. She reported that three student scholarship awardees were selected.

District Classified Senate had no representation at this meeting.

**PRESIDENT OF STUDENT SENATE OF CHABOT AND PRESIDENT OF ASSOCIATED STUDENTS OF LAS POSITAS COLLEGES**

Student Senate of Chabot College had no representation at this meeting.

Associated Students of Las Positas College had no representation at this meeting.

**APPROVAL OF AMENDMENT TO THE NURSING PROGRAM AGREEMENT WITH VALLEYCARE HEALTH SYSTEMS, DISTRICT-WIDE (Agenda Item 4.5)**

Trustee Mr. Vecchiarelli reported that he pulled this agenda item from the consent calendar to express his concern, specifically regarding the 90 day cancellation policy. He noted that a cancellation should occur at the end of a semester or term. He requested a presentation in the near future on this program and its future role.

Chancellor Jackson reported that she has discussed the Nursing Programs with both College Presidents. She reported that the District is in the process of making arrangements

to address some of the concerns expressed. She reported that an update will be provided to the Board either as a written document or as a presentation at a future Board Meeting.

Motion No. 3

Trustee Dr. Cedillo made a motion, seconded by Trustee Dr. Gin, to approve the Amendment to the Nursing Program Agreement with ValleyCare Health Systems for Continued Support of the Students in the Nursing Program. The agency will continue to provide the use of clinical and work-site learning facilities for students to improve their learning experience through internship or clinical placement program and accept the funding for faculty and staff support at their Educational Facility in Livermore. The term of this agreement is August 18, 2014 and shall continue until May 31, 2015. It is further recommended that the Board authorize the Vice Chancellor, Business Services, to execute the agreement on behalf of the District.

Motion carried unanimously, 5-0, with Trustees Dvorsky and Gelles absent.

**PRESIDENTS OF CHABOT AND LAS POSITAS COLLEGES**

Dr. Susan Sperling, President of Chabot College, submitted a written report to the Board. Dr. Sperling reported that on April 20, Chabot College and the District hosted a successful “Future Forum”, a Congressional listening tour with Congressman Eric Swalwell and other young representatives to hear the key concerns of students, ages 18 to 21 years. She expressed appreciation to Chancellor Jackson for bringing this event to the College. Dr. Sperling also reported on the Dr. Reed L. Buffington Memorial Event on Sunday, April 10; and expressed appreciation to those that attended, including Trustee Vecchiarelli who spoke about Dr. Buffington. She also reported that she recently hosted a very positive and well-attended Brown Bag Forum on the Hesperian Landscaping/Hardscaping Project.

Dr. Barry Russell, President of Las Positas College, provided a written report “Las Positas Connection.” He reported on the successful 40<sup>th</sup> Anniversary Open House and Ribbon Cutting held on Friday, April 17. He also reported that on Saturday, April 25, the Las Positas College Foundation will hold its “Best of the Best”, the last for Dr. Ted Kaye who will soon be retiring. He reported that student elections are being held this week. He also reported that the last Club Day of the semester is scheduled for next week. He also reported that a team from Student Government attended a national student government conference. Further, he noted the presentation of the ASLPC accomplishments at next month's Board Meeting.
