Board Approves the Facility Master Plans Bond Project List Update for full \$950Million Update Environmental Impact Reports

#### **Questions and Comments**

Trustee Mitzman stated Board President Maduli and himself recently attended the Oversight Bond Committee meeting and the feedback he received from attendees was positive. He asked how does this update of the Facility Master Plan tie into the District Strategic Plan and the Educational Master Plan for the two colleges. VC Letcher stated strategically this District when they selected the firm to prepare the Facilities Master Plan, they selected the firm that created the Educational Masterplan for both colleges. He added, the continuity of the delivery of service has allowed them to integrate the Educational Master Plan data into the Facilities Masterplan with the identified areas of growth that were in the Educational Master Plan were carried forward through the Facilities Master Plan because of the linkage of services. Trustee Mitzman asked if it was the same company. VC Letcher stated yes.

Trustee Sbranti stated in reading both reports for Chabot and Las Positas College the student surveys listed parking as the number one issue they would like addressed, what is the phasing you see in those improvements. VC Letcher agreed parking is an issue at both campuses. He stated Las Positas College there is a plan for construction for additional parking at the east end of campus. He stated at Chabot College that is an impacted site with limited land and is a much smaller campus then Las Positas College. He added, the parking issue at Chabot will take additional studies but there is discussion in the Master Plan about a parking structure. Trustee Sbranti stated the parking structures are expensive, he hopes the sequences of the other improvements can happen on the front end to relieve some of it. Trustee Sbranti asked what study was done in terms of a market analysis for the jobs of the future to match with the facilities that are being constructed to tie into the local economy

for workforce development. VC Letcher stated in part of the Educational Masterplan there was a jobs assessment done that link the Educational Master Plan growth through the Facilities Master Plan process this study was updated during the FMP process to validate the program growth at both campuses and to address emerging employment opportunities that are being seen. He added, this will be added as an appendix to the Final Facilities Master Plan. Trustee Sbranti stated there is some great opportunities to grow other programs. He asked if housing is a possibility in the inclusion and was looked at in the Facilities Master plan. VC Letcher stated Measure A Funding does not include Student Housing, that item was not moved forward however housing has been a discussion point with Las Positas College and local developers, not at Chabot College due to our land lock campus and reduced square footage.

Trustee Sbranti asked if Off Site Expenditures is serving the students, does bond dollars have to be spent on the campuses of Chabot and Las Positas College or if there are programs that benefit students can they be spent elsewhere. VC Letcher gave an example of our joint use agreement with the City of Hayward, Hayward Fire Training Academy is where were spending bond dollars for a program located off campus. He added, previously in Measure B we had programs affiliated with Adult School Programs with the City of San Leandro. Lastly, he stated as long as we can come to an agreement with our partner agencies we can spend bond dollars at that capacity.

President Maduli stated there has been a lot of discussion state wide in respect to studentfaculty & staff housing. San Mateo is the only Community College with Faculty and Staff Housing, adding Bond dollars were not used.

Trustee Granger asked what the capacity load is over 100% and if it is good or bad. VC Letcher stated capacity load is the functional math equation that takes your number of weekly student contact hours within the campus and divides it by the square footage available, divide by the hours of the week and weeks in a semester. He added, in the formula is the square footage based on programs for the number of students enrolled. The state considers us to be balance if we come up with 100%, that is the number the state uses as our optima, if we are above that 120%, the state considers that as we are over constructing or we are under students.

Trustee Granger asked for further explanation regarding specific to the funding sources. VC Letcher stated if we submit our application for a state project (state bond dollars, state fund dollars) historically it has always been a state bond dollar. It would have to be state wide bond dollars that we would match 50%.

Trustee Granger asked for confirmation, if there are items in our Facilities Master Plan that we have unmet need from the Master Plan relative to the amounts available and our current bond. VC Letcher confirmed there is approximately \$530 million dollars identified at each college plus \$120 million at the District level. In total we have \$1.3 billion dollars in need identified in our Facilities Master Plan and a \$950 million bond measure of which state

funding is an option and public private partnerships are option to leverage our dollar forward.

President Maduli stated because we have unmet needs and \$950 million, I like what you've done in terms of integrating all the projects within the colleges. He asked how all the projects that were identified as phase one tonight, how are they categorized based on need. VC Letcher stated each college identified a list of projects from 2017, and put forward a vote from Facilities and Technology Committees. He added, he believes there was a democratic process to identify the priorities on both campuses.

Trustee Gin stated he enjoyed VC Letcher's presentation. He complemented Trustee Sbranti by stating he brings a wealth of knowledge to the Board from his past experience with the City of Dublin.

Trustee Gin asked VC Letcher when Measure B came on board we had a five-year construction plan, is that the same with Measure A. VC Letcher stated Measure A has compliance requirements for years one, two, three and five. He added, that Bond Council will have to weigh in on why there is no compliance requirements for year four. Every time we sell a bond we go out for a series of Bond sells and we end up with a series of bond spend downs on requirements.

Trustee Gin asked during Measure B we were in a recession where we were able to save the District significantly, he understands we again might be heading for another recession during the Measure A timeframe, do we expect to capitalize on that again. VC Letcher stated if we have another downturn of the economy we will take advantage of that.

Trustee Randolph stated the District in the past had an agreement with Local Labor governing projects, will this practice continue in the future, if so does that have an impact on the costs identified. VC Letcher stated our District in the past has had project stabilization to provide labor forces, that should be an agreement between the District and Labor Unions that are signatory to our agreements. Furthermore he added, he has had meetings with Labor Unions and stated he laid out his expectations and is hopeful to build partnerships.

President Maduli stated in your last District you had a PLA/PSA agreement. VC Letcher stated we currently have a PLA/PSA agreement with the Trades Council which is project specific for Measure B projects, we don't have any active projects that are covered by the PLA/PSA agreement. He added there was a PLA/PAS agreement with Measure B that went through an initial period and an extension with an identified list of projects. President Maduli confirmed that was only for Measure B. VC Letcher stated yes.

President Maduli confirmed prior to entering into any agreements the Board will be made aware. VC Letcher stated yes and will be kept updated throughout the process.

President Maduli stated he noticed overspending at Las Positas on Measure B spending and how asked how are they going to be covered. VC Letcher stated Measure B continues to earn interest through March, we had approximately \$2 Million in interest earnings on Measure B that has not been allocated out to projects. He added, those funds will be allocated out to the colleges. He stated there is encumbrances in the Las Positas project we don't expect to pay out so currently we are cancelling contracts and going through an accounting process, with allocation of interest earning between Chabot and Las Positas in the clean up on the "budget dust" that remains on projects that were encumbrances that we didn't expect that number is a zero. Lastly, he stated he is not concerned with the deficit number today.

President Maduli stated as were closing out Measure B, are we going to have an accounting of the interest of this; example what projects were funded, did this fund any manager positions. VC Letcher stated to his knowledge the interest earnings have always been allocated to projects. He added, a Bond List revision will be presented to the Board with a line item stating interest earning with an allocation of where the dollars go.

President Maduli stated you outlined in your presentation there are \$360 million in projects, when are you looking to go out for the second amount. VC Letcher stated we have to meet our spend down requirements. We have met year one and are on track to meet year two once we pay The City of Hayward to achieve our spend down. Lastly he stated, we are out 18-20 months before we need to go out for the next issuance of the Bond.

Trustee Mitzman made a motion, seconded by Trustee Gin to adjourn the meeting at 9:21 p.m.

Motion carried unanimously, 6-0.
