Las Positas College Academic Senate President, Ms. Sarah Thompson provided the following report:

Ms. Thompson reviewed the following AS1: Resolution in Support of the AAPI Community

WHEREAS, The Las Positas College Academic Senate represents the interest of the Las Positas Community College Faculty; and

WHEREAS, The Asian American and Pacific Islander (AAPI) Community has been the subject of racist rhetoric, action, and violence throughout their history in the United States of America which has been most recently expressed in the murders of Delania Yaun, Hyung Jun Grant, Soon C. Park, Xiaojie Tan, Daoyu Feng, Suncha Kim, and Yong A. Yue in Atlanta, Georgia on March 16, 2021; and

WHEREAS, The Las Positas College Academic Senate recognizes the impact this racist rhetoric, action, and violence has on the psychological and physical well-being of the faculty, staff and student members of the AAPI Community; and

WHEREAS, The Las Positas College Academic Senate recognizes that silence in the face of racist rhetoric, action, and violence constitutes complicity in the continued oppression of the AAPI Community; now therefore, be it

RESOLVED, That the Las Positas College Academic Senate stands in solidarity with the AAPI Community in condemning racist rhetoric, action, and policy which has resulted in the increase in violence against members of the AAPI Community; let it be further,

RESOLVED, That the Las Positas College Academic Senate thanks President Foster and those who spoke out early in support of the AAPI Community, including Stella Del Rosario, Frances Hui, and David J. Powers; let it be further,

RESOLVED, That the Las Positas College Academic Senate will explore concrete action to support our AAPI Community members' academic and psychological needs.

2.2 PRESIDENTS OF CHABOT AND LAS POSITAS COLLEGES AND DISTRICT CLASSIFIED SENATES

Las Positas College Classified Senate President, Mr. David Rodriguez reported on the following:

It is a privilege to serve our community during this time. It is both a challenge and an opportunity to try and address the various needs while trying to maximize our service to our community. In the last several years, the state's policy, in effect, impresses that our students and community educational needs are less than those of others', even though our families struggle to afford higher living expenses. We've bravely made the case that these policies do not adequately measure nor equitably address our students' needs. Without policy change, this translates to, somehow addressing students' needs with less or pare down what we provide. The questions we

have been wrestling with these recent years are: How do we best respond to this? What can we do to keep our organization healthy and available to the community that relies on us for access to education? How do we do so in a way that upholds our values of fairness, responsibility, and integrity? How do we avoid infighting and find ways to respect one another throughout this process?

Our students and community need all of us to be ready and able to support them: faculty, classified professionals, and administrators. Many of our students, especially those rising from difficult contexts, need us to work together to help them through their journey, to provide clarity and a genuine, "Welcome! We are here for you." This welcome is characterized, shaped, and expressed throughout our institution by dedicated and supported individuals.

Our civic ethos, our values, tell us that the loudest or strongest often do not provide sufficient input toward fairness nor a complete assessment of the situation. Arguably, I represent one of the groups in this district with the smallest voice. And LPC classified have absorbed and sacrificed a lot over the years in support of "Students' First" and fiscal responsibility. But in order for this sentiment to prevail we need everyone to do their part fiscally. The past nose-to-the-grindstone dedication by my colleagues at LPC has meant that earlier sacrifices have often been taken for granted. This is why I appreciate the refreshing approach of our current college leadership for their wonderful support of classified. But looking at a district-wide fiscal lens, is difficult to see relief. How can classified at LPC meet the burden of increased efficiency needed to solve our fiscal situation? Resources never reach us with sufficient parity, and a sense of an afterthought and inconsistency. I'm hopeful this will change. And I definitely see room for improvement and innovation in how we do things, but I also see the effects of past neglect that limit our ability to pivot, respond, and maintain. Additionally, I see fear and worry from many of my classified colleagues of what might come next. If we do not take a balanced fiscal approach to this issue, district-wide, and all of us do our part, the brunt of the hurt will fall on those who can least afford to bear it. Not just those who I represent, but rather the most at need students in our district who stumble over our processes. We need everyone to proactively have fiscally responsible conversations so we can truly put students' first. Reaching across our District, I hope we come up with balanced solutions. Once that make real improvement on how we work together as a District, and not just shift the burdens around. Otherwise, the values and ideals we project outwardly ring a bit hollow; how can they hold weight if we cannot be equitable with ourselves.

I thank you for listening. I know I don't have all the answers, nor have everything right. But I truly appreciate the work and contributions we all make. I deeply respect our role as institutions of higher education, our primary functions, and how we extend access to our community. I know we can meet this challenge and address our diverse needs across the District.

Chabot College Classified Senate President, Ms. Noell Adams provided the following report:

- Engaging in succession planning to identify and support future classified professional shared governance leaders
- Participating in district and college budget discussions
- Reviewing and providing feedback on board policies and administrative procedures
- Supporting Black students at Chabot through the Black Excellence Collective 10 x 10 villages
- Coordinating a professional development workshop and speaker series for classified professionals
- Honoring and celebrating Chabot College classified professionals

2.3 PRESIDENT OF STUDENT SENATE OF CHABOT AND PRESIDENT OF ASSOCIATED STUDENTS OF LAS POSITAS COLLEGE

Chabot College Student President Senate, Ms. Theresa Podesto reported on the following items:

Ms. Podesto stated the senate participated in the California Community College General Assembly event last week where thirty resolutions were passed. She stated they are working with OER on funding for free text books and materials. She stated that elections will be open until Sunday. She stated they are in the process of reviewing SSCC scholarships and will be awarding \$30,000 this year. Lastly, she stated that they are collaborating with Las Positas to make both campuses smoke free.

Las Positas Student President Senate, Ms. Saba Salehifar report on the following items:

Ms. Salehifar stated today the Market provided over one hundred and fifty-four bags to students and the community. She stated extra bags were donated to Tri-Valley Haven and other local food shelters. She stated the senate has election voting taking place until April 25th. She stated that student government hosted a multi-cultural talk circle, where students were encouraged to speak about their culture, diversity and breaking down Islamic stereotype. She stated this Friday they will be holding a photo editing workshop. She stated prior to finals they are planning a stress-free event that will include guided meditation and yoga classes. She stated they are also planning a Chill and Chat event in the near future for students to openly express their feelings regarding hate crimes. Lastly, she stated student government has put forth a program support initiative to provide funds for departments.

GOOD OF THE ORDER

Ms. Rachel Ugale, Chapter President SEIU, reported on the following:

There have been an overwhelming number of history-making events that have occurred since the last time we met, both good and bad, that are changing who we are as a society, each serving as a call to action, and each reminding me that the work that we do as a District in serving our students and additionally the work that I do as a unionist within the labor movement are two of the most important things I have done and will do in my lifetime. I am honored to be able to serve in different capacities to support our communities and I am so proud of how we have come together recently, but there is so much more work to do. And I know we will come through. I have seen it through decades of service to this District.

Return to Work Discussions

Our chapter leadership is actively working with management on items around returning to the worksites, and we look forward to meeting with the District tomorrow afternoon for our continued discussions. We recently surveyed our unit members on this topic and we are focused on how we can return to work in the safest possible manner. We are ramping up our discussions, so there will be much more to report in the near future.

New Chapter Leader Appointed

I am proud to announce the appointment of a site secretary for Las Positas College! Catherine Alfaro Gomez was recently sworn in to the role and has hit the ground running, actively participating in our discussions with management, and setting up site meetings so we can increase our interaction with our unit members.

New Field Representative

Another change that occurred recently is the recent appointment of a new field representative to our chapter. Ryan Fettes comes to us from the SEIU education team and we're looking forward to working with him as we continue to organize as a unit.

Mr. David Fouquet, President, Chabot-Las Positas Faculty Association, provided the following report:

The week just prior to Spring Break, we held General FA meetings for faculty at both campuses to discuss the myriad issues surrounding the phases of re-opening our District to F2F instruction. Most of the discussion centered on what's going on in the Fall, and the anticipated resumption of teaching and working on-campus in Spring 22. Needless to say, there is lingering uncertainty around the public health situation, and that no one knows what the student demand for F2F instruction will be in Fall 21 & Spring 22.

Some specific points of discussion:

• What CV-19 vaccination and testing policies will be in place for faculty & students, including possible booster shots this Fall, and how to manage employees (& students) who decline vaccination;

- How to finance or otherwise provide for smaller class sizes for faculty who volunteer to teach on campus this Fall;
- The importance of conducting learning preference surveys (F2F v. hybrid v. online) with our students;
- Provisions for enabling faculty willing to try a *hyflex* model (*i.e.*, instruction with technology that allows a faculty member to lecture to half the class in person while the other half participates remotely);
- The degree to which shared governance meetings can be held via Zoom, going forward;
- What safety protocols will be needed for counseling & librarian faculty;
- How Federal dollars might be leveraged to help facilitate students' return to campus, especially in Spring '22;

The FA's Negotiating Team continues to meet frequently with the District to sort through these and other issues facing us as we emerge from this pandemic.

5.10 ADOPTION OF RESOLUTION 06-2021, IN THE MATTER OF ESTABLISHING A TRUST TO BE USED FOR THE PURPOSES OF INVESTMENT AND DISTURSEMENT OF FUNDS IRREVOCABLY DESIGNED BY EMPLOYER FOR THE PAYMENT OF ITS OBLIGATIONS TO ELIGIBLE EMPLOYEES AND FORMER EMPLOYEES OF EMPLOYER AND THEIR ELIGIBLE DEPENDENTS AND BENEFICIARIES FOR HEALTH INSURANCE AND OTHER SIMILAR BENEFITS

Chancellor Gerhard stated this Resolution will establish and constitute a retirement board of authority. He stated at a previous meeting the Board had approved the creation of an irrevocable trust that will be used to house funds that ultimately are set aside for retirement benefits. He stated this Resolution will oversee the day-to-day operations of investments in this irrevocable trust. He added that the Board will periodically receive reports regarding the activity.

VC Nicholas stated this is the second Resolution piggybacking which creates the retirement Board of authority. He stated this will be populated with the members that are listed here upon which the bylaws for the trust will be established. He stated this will allow monies to be moved that have already been identified into the irrevocable trust which will have a profound impact on our actuarial reports going forward.

9.2 APPROVE THE CLPCCD FOUNDATION BYLAWS AND ARTICLES OF INCORPORATION

Chancellor Gerhard stated over the course of the last year the Board of Directors for the Chabot-Las Positas Community College District Foundation has been undergoing a strategic planning process to review the aged bylaws and articles of incorporation. He stated in the review process it was identified that both documents were over twenty years old and needing to be updated to reflect current environment and activities ongoing within the district.

He stated the Board hired a consultant and legal counsel to move us in updating these two documents. He stated these two documents are presented this evening for review and approval. He stated the foundation is an auxiliary of the foundation of the District and therefore, these documents are required under statute of the law to be presented to the Board of Trustees for review and approval. He stated in the Articles of Incorporation under section 7.1.3 there was one unintentional omission. He stated the current and long-standing practice within our District and Foundation as an auxiliary is one member of the Board of Trustees is an ex-officio member on the Chabot-Las Positas Community College District Foundation. He stated that point was missed in terms of reviewing and updating the documents with outside legal counsel therefore, this needs to be added to page three as a subsection eight that would be consistent with our historical practice and our old language of Articles of Incorporation. He stated the language would read: in addition to the other seven ex-officio members the eighth would be the Chabot-Las Positas Community College District Board of Trustees president or designee.

President Randolph thanked Chancellor Gerhard for reviewing the revision. She stated the Chabot-Las Positas Community College District Foundation has a history of having a Board of Trustees member on this committee.

10.1 PRESIDENT OF CHABOT AND LAS POSITAS COLLEGES

Dr. Dyrell Foster, President, Las Positas College reported on the following items:

President Foster thanked Mr. Fouquet, Mr. Pagiou, Mr. Thompson and Ms. Ugale for their powerful words in regards to the violence, hate, racism and social justice that continues to play in our country. He acknowledged President Sperling, Chancellor Gerhard, VC Fong and the Board for their collective leadership and support across the District to address hate and racism. He stated that today marks the first day of registration for Summer and as they approach Fall they are focused on enrollment and taking proactive steps to promote. He stated one of the ways they are promoting is by hosting virtual information sessions for parents and families. He added fifty-three families attended last week's session. He stated to compliment these sessions they have established separate educational planning sessions for the students to meet with counselors to help facilitate their on-boarding and enrollment. He thanked VP Whalen, Mr. Alvarez, Ms. McWhorter, Ms. Anne Kennedy and Ms. Alfaro Gomez for their participation and support. He also thanked three students who shared their stories on why they chose Las Positas during these sessions. Lastly, he stated the National Civic League has named the City of Livermore as one of the twenty finalists representing fifteen different states to compete for the honor of being named an All-American City. He stated the next step in the competition is a virtual presentation at the All-American City awards event.

Dr. Susan Sperling, President Chabot College reported on the following items:

President Sperling thanked President Foster for his kind words and all the work he has done with social justice. She also thanked Dr. Pagiou and Chabot's staff and students for educating everyone about Anti-Asian violence in our communities and resisting this violence. She stated she appreciated the words spoken this evening regarding the verdict; justice is a long road, but today was a step forward. She stated Chabot College has significantly increased its rates of graduation degree completion and transfer over these last years and we have seen a high rate of student success in a number of our signature programs. She added several of these programs Chabot created are now statewide and they link excellence in academic preparation with excellence in student support. She stated they are also seeing student access trends in their program for student athletes' scholars. She stated that through some meticulous work they have been able to maintain support and face to face classes safely for student athletes. She recognized Dr. Kramer and Mr. Manos and asked them to say a few words about the extraordinary work.

Dr. Kramer stated Mr. Mano unfortunately could not attend this evenings meeting. He thanked everyone for the work there doing and passing the resolutions. He thanked President Sperling for recognizing the work that the student athletes are doing on campus. He stated Community College Athletics have been shut down across the country and has suffered greatly from the lack of competition however with the support of President Sperling, District, President Thompson and the senior administration we found ways to keep our student athletes engaged and interested without competing. He stated by doing this we have seen some great results in the classroom and dedication to Chabot. He thanked Athletic Director Mr. Drouin who has done a great job in moving them forward through the pandemic. He stated this year has been one of the most successful academic years in their athletic

programs; the Fall semester had over 100 student athletes earn a 3.0 to 4.0 GPA with passing of at least twelve units. Lastly, he stated this is a testament to the coaches, staff, instructors and classified professionals who create an opportunity for students to be successful.

He thanked everyone who participated and volunteered at the Market. With excitement he stated he is now the proud father of a healthy son.

President Randolph thanked Student Trustee Polanco for his suggestions. She also congratulated him on his newborn son.

Student Trustee Lin stated he received his second vaccination dosage last week. He stated he is excited to hear the state will fully open soon, as his fellow students are looking forward to coming back on campus.

Trustee Granger stated she finds hope in hearing all the amazing things everyone is doing to support our students no matter what they are facing. She thanked everyone who interacts with our students and is happy to play a part in that through our policies.

Trustee Sbranti stated he has received positive feedback from student and parents regarding parent night at Las Positas. He stated this work needs to be commended, the pathway to success starts with good on-boarding and orientation. He thanked everyone for staying student-centered, focused and continuing to give them hope during the pandemic.
