# **Community College District Plans for the Future**

(Pleasanton, CA) - The Trustees of the Chabot-Las Positas Community College District took a step toward securing the future of the District by placing a general obligation bond on the March 2, 2004 ballot. The bond measure will allow for major safety repairs, renovations and modernization of the nearly 45 year-old Chabot College campus in Hayward. The measure will also provide for new, up-to-date classrooms and science and technology centers at the campus. The general obligation bond measure will also provide Las Positas College in Livermore, with funding for repairs and renovations. Most importantly, the measure will ensure that Las Positas can add more classroom and educational buildings throughout the campus to meet the growing demand for higher education by Alameda County students. "Our colleges have two primary goals: to give our students job and career training and prepare them to transfer to a four year university", said Dr. Susan Cota, Chancellor of the Chabot-Las Positas Community College District. "This bond measure will ensure that our students have access to the 21st century education that they need to succeed." The general obligation bond measure is the culmination of 18 months of planning by both Chabot and Las Positas Colleges. Professional facility planners, architects, educators,

students, community leaders and local business owners were involved in mapping out the future of each college and the facilities that are needed. The \$498 million bond measure will cost homeowners \$19.88 per every \$100,000 of their homes assessed valuation (not market value). The general obligation bonds are 25-35 years in length. No bond monies can be spent for salaries or administration. By law, an independent Citizens Oversight Committee must be established to oversee the implementation of the bond projects. # **Facilities Bond Survey Results Show Support for Colleges**

(Pleasanton, CA) - At it's meeting last night the board of trustees of the Chabot-Las Positas Community College District received the results of a survey to determine voter support for a facilities bond to remodel and renovate Chabot College in Hayward, and complete the build-out of Las Positas College in Livermore. Fairbank, Maslin, Maullin & Associates, an opinion research firm, conducted the survey by telephone with 600 registered voters in the Chabot-Las Positas Community College District service area. More than 71 percent of the voters surveyed said they would vote yes on a facilities bond measure to support the two colleges. Survey results also showed voter understanding of the importance of Chabot and Las Positas Colleges during tough economic times. They are aware of the critical roles the colleges fill such as training police, fire and health care professionals in addition to re-training the workforce. "We are very pleased with the results of the survey," said Dr. Susan Cota, district chancellor. "Our colleges have been serving the East Bay for more than 40 years. The results of the survey show us that our community members know who we are and appreciate what we do for them." The Board of Trustees will continue to study a facilities bond to improve the two colleges which serve more than 22,000 students annually.
