Vaccine mandate software

- Thousands of vaccination records from students
- This does not apply to on-line only students - Campus only
- Product is Cleared-for. Cloud hosted, HIPA compliant. Allows for students to upload document (picture of QR code or vaccine card), when approved, goes into Banner.
- As of 2021/11/19: 40,000 students from last three terms. Currently 146 records being reviewed. Authorized 4,226 students to date.
- Communication between Clear-Four and student is a unique URL. Personalized to each student. Link sent to their Zone Mail because of privacy reasons
- If a student has received 2 doses but not yet met their 14 day waiting period, they are still being approved.
- You are being asked to upload the documents before their registration appointment. Students get a 5-day notice
- Non-vaccinated students OK for on-line classes

ITS Total Cost Ownership

- One of our goals
- Model for funding IT in an organization. Our situation is funding part of the department. Those things that would grow with the bond program.
- There is more to the cost of equipment than just its purchase. The model is there to account for the cost of growth.
- Approved by the board in conjunction with maintenance and operations TCO
- Grounded in the Gartner group - reputable organization

- If redone, a distance education component is needed
- 2016: \$2.3 million in server costs
- 2016: \$4.6 million in Desktop/Laptops costs

- Smart Classroom growth: 246% Chabot, 542% LPC (2008 to 2016)

Email

- Our Barracuda servers will now point to our cloud servers allowing us to shut-down our local servers
